## **CIVIC CENTER MEMBERSHIP**

Membership includes use of the basketball gym, track, and game tables.

- Free for Vestavia Hills' resident (2 forms of proof of residency).
- Must renew residency information annually from date of acquisition. Badge can be kept perpetually as long as member keeps residency.
- Non-resident fee is \$5/day and must be accompanied with a resident member. No more than 2 non-resident/guests per member.
- All clothing attire must be worn appropriately. Shirts and Shoes must be worn at all times. Non-marking athletic shoes are allowed. Shorts and pants must not be sagging.
- Profanity or vulgar language is not allowed and will not be tolerated.
- Any altercation, verbal or physical, will result in ejection from the gym

- Food or drinks are not allowed in the gym other than bottled water.
- Alcoholic beverages, smoking and tobacco products are not allowed in or around the recreation center.

- No pets allowed.
- Violators will be asked to leave the premises.

### Vestavia Boys Rec Basketball Meeting Minutes Wednesday, May 21, 2014

The purpose of the meeting was to elect new officers and to review miscellaneous items related to the league. The following is a summary of the items that were discussed:

- 1. Election of officers. Mark Smith nominated the following slate of officers:
  - President Jackson Bryant
  - Vice President Kirk McCulley
  - Treasurer Barry Brown

No other slates/candidates were nominated. The votes received by email and/or in person (from Board members M. Smith, J. Bryant, K. McCulley, J. Stoves, D. Payne, J. Pietrantoni, K. Hunton) were unanimous for the slate of officers. No votes were received from B. Barranco, J. Johnson, S. Roby, or B. Spain.

- 2. The Boys basketball bank account has a balance of approximately \$31,000. Mark Smith provided copies of bank statements (approximately 2 years) to Jackson Bryant.
- 3. Mark Smith's name will be removed from the bank account. Jackson Bryant and Barry Brown will be added to the account. Mark will contact Renasant Bank to initiate the changes.
- 4. Mark Smith has approached Bill Ivey about hosting summer skills camps for grades 1-6. Mark will arrange a meeting with Bill Ivey and Jackson Bryant to discuss in more detail.
- 5. The league received numerous compliments on the uniforms and the long-sleeve shooting shirts. Jackson Bryant will ask Kirk McCulley to handle the uniforms again in the upcoming season.
- 6. The Board will consider changing financial transaction service providers.
- 7. The Board is interested in considering a consolidation of websites with baseball and/or other Vestavia youth sports leagues. Kirk McCulley has been researching this issue.
- 8. Mark Smith reviewed some of the basic annual financial commitments that are included in the budget. The commitments include payments to Pizitz, Central, and Liberty Park for floor refinishing and/or gym repairs/improvements. Mark Smith was told by a flooring contactor that the Central gym floor may need to be stripped completely and refinished with a heavy-duty oil-based finish (as opposed to water-based) so that it would last longer and provide better traction. Jason Burnett generally handles communications with the schools, although Mark Smith has been communicating directly with Roger Dobnikar at Liberty Park MS.
- 9. The Board will meet again in the Fall, prior to the basketball season.

The meeting was adjourned.
