VHGSA Report For Vestavia Hills Parks & Recreation Board - November 2015

Our rec fall ball season concluded on October 18th and went extremely well. We had a lot of first time players and coaches that we hope will carry over to their coming back for spring.

Our four Vortex teams have been playing in tournaments throughout the fall. All four should complete their fall seasons the weekend of November $14^{th} - 15^{th}$.

We plan to open registration for our spring season on December 1st. Our board will be meeting on Sunday November 8th to finalize all dates for the spring season.

A significant issue facing our league will be deciding which organization to play with for the 2016 season. Our current organization, USFA, has pretty much imploded due to significant leadership changes. Our most likely options will be to return to USSSA (where we had previously been), or look at going to NSA. We are still evaluating our options and will make a decision as soon as possible.

We again want to thank Parks & Rec and the city for approving funds to resurface Fields 1-4 at Liberty Park. This has been badly needed and we are excited about having this work done in time the spring season.

One item that I want to go on record is in regard to field prep. STS has done an outstanding job this fall working on the fields and prepping them for our practices and games. I was recently informed that STS would not line our fields for practice games or tryouts as that was not in their contract. I would like to request that that be reconsidered. When we have practice games, particularly with the Vortex teams, it is typically against teams from other parks. It's my desire that we have our fields looking their very best in those situations as we show off our facilities to visitors. I have a similar feeling on our tryouts. I want our fields to look at their absolute best on those days as we want to make the best possible impression on our parents in regard to our facilities. The fact is that tryouts and practice games really do not occur that often, and we certainly aren't concerned about having the fields lined for true practices. I don't know if this would require a change in the contract wording with STS, or perhaps if it could just be reaching a level of understanding with them, but I would very much like to see this happen, again simply to make sure that we make the best impression possible for these particular events.
