Executive Summary

RFP Vestavia Hills Concessionaire

Introduction:

For the past three years, Vestavia Hills Parks and Recreation has a contract with Turner Food Systems, LLC (TFS) to provide concession services to all of our athletic facilities for sports programming.

On August 5, 2016, we sent out a Request for Proposal (RFP) to eleven (11) concessionaires (see attachment) for the operation and staffing of the Parks and Recreation Concessions for three years. A sample contract was included for their review. Sealed proposals were to be open at city hall on August 25. Only our current vendor, Turner Food Systems, LLC submitted an RFP. The majority of the eleven companies were not interested and only one said he simply missed the deadline.

An executive summary was provided to the Park Board for their review to be approved at their September 20 meeting. It was decided to table the issue and further discuss the proposal and survey other parties.

The Parks and Recreation Department contacted 17 other municipalities in the metro area (see attachment) to ask who they use for concessions. Seven of them use Turner Food, seven allow the parents to operate concessions, 2 use one of the vendors we asked for an RFP, as well as one more. We also reached out to concessionaires with the Birmingham Barons and the Bruno Event Team, with no leads resulting.

The Park Board held a meeting with all sport boards to gauge interest in each board running the concessions themselves, with no interest on the table from Baseball, Softball, all three Football leagues, Lacrosse, or Soccer.

We met with Turner Food on October 31st to discuss some key items we would like to see moving forward...

- Sports should send schedules to P&R and P&R sends that information to Turner Food Systems (TFS). (There should not be direct instructions from sports to TFS)
- TFS agrees to have concession windows open at least 45 minutes prior to first scheduled event.
- Start the process of obtaining information to place the entire Square system in each location to serve as a point of sale system for inventory purposes as well as process credit card transactions.
- If a sport wants special event items to be sold (food trucks, bake sale, etc.), they should make those requests to Parks and Rec at least 2 weeks prior to the event. Parks and Recreation will get that information to TFS. TFS will coordinate with P&R and sports representatives on these events. No more than two weekends per sport per year.
- \$100 fine imposed to TFS if his staff doesn't show up and \$100 fine to Sports if they schedule games but no one shows up. Weather related cancellations should also be run through Jason Burnett and Jim Treest so there is documentation. If concessions are open and there are no games/events, concession worker is to call the P&R maintenance staff to have them verify there is no activity. The same goes for the concession not being open sport representative should contact park maintenance to have them verify the concession stand is not open. The park maintenance personnel should take a picture and text Jason Burnett, Jim Treest, and Bobby McDaniel.

The Park Board will discuss this item under new business for their November 15 meeting and will send their recommendation to the city council for their November 28 meeting.

RFP Summary

Turner Food Systems, LLC will provide operations of all concessions in the city of Vestavia Hills Parks and Recreation system. Turner Food Systems, LLC will be responsible for making available for purchase items of food and nonalcoholic beverages to the general public participating in or attending recreational activities. In return for this exclusivity, the selected vendor must provide the City with a revenue stream based on activity levels.

The current RFP submitted by Turner Food Systems, LLC continues the current concession and catering management services for the City of Vestavia Hills Parks and Recreation.

Currently, TFS provides the city 15% of gross receipts of zero to \$250,000, 17% for \$250,001 to \$350,000, 19% for \$350,001 to \$450,000, and 20% for \$450,001 and greater. In 2015, the city's cut was \$32,835, in 2014 it was \$44,880, and in 2013 it was \$45,050

In the RFP, TFS would provide the city 10% of gross receipts of zero to \$350,000, 12% for \$350,001 to \$550,000, and 15% for \$550,001 and greater. If this was applied to the past three years of revenue, in 2015 the city's cut would have been \$21,890, in 2014 it would have been \$26,400, and in 2013 it would have been \$26,500.

Basically TFS is attempting to bring to the attention of the Park Board the fact that their revenue has decreased substantially since the LP tournaments have been removed since we are focusing more on recreation baseball there, but their expenses have remained constant. Expanding baseball to Liberty Park has increased their costs (dual staffing of facilities). However, both parties understand though the commission percentage has decreased, the level of service should be elevated.

As far as enhancements, TFS listed and offered to do such things as market the facilities, sell sponsorship's for the facilities, develop a merchandising plan (it will not interfere with the Soccer business model), start using their portable units daily (ex: placing the fully functional BBQ trailer in a spot which can generate daily revenue pretty much year round), provide ATMs at special events, coordinate special events, place a Mini Melts Ice Cream vending machine in the Civic Center and find ways to develop catering.

TFS also mentioned the need to develop a plan to remodel / build Exchange Field since the Health Department will no longer allow that facility to 'piggy-back' off Wald Park. We are looking at expanding food offerings.

The Park Board reserves the right to reject any and all proposals; to waive minor irregularities in any proposal; to request clarification of information submitted; to request additional information from any proposer; and to make the final decision as to the best proposal.

Recommendation

Considering the concessionaire profession/market is so small in the Birmingham area and TFS has always provided us with a professional service/product, my recommendation is to continue our relationship with TFS LLC and obviously continue to improve our offering to the citizens of Vestavia Hills, AL.

Background of Ability and Experience

Turner Food Systems was awarded the concession agreement for the Liberty Park Sports Complex in February 2006. Turner Food Systems had been under contract with the City of Vestavia Hills as a third-party vendor for specific menu items on a verbal agreement since August 2005 until the award of the full concession agreement in February 2006.

Turner Food Systems, through its affiliate Alabaster Concessions, was awarded the concession agreement for the City of Alabaster in December 2006, with the agreement effective February 2007. The agreement expired in January 2010 with operations being transferred to the Alabaster Sports and Entertainment Foundation (ASEF), a non-profit organization, whose mission is to facilitate the planning, execution and maintenance of Sports and Entertainment facilities and improvements serving Thompson High School, the community of Alabaster and Shelby County, Alabama.

In January 2007, Turner Food Systems was awarded the concession rights for the Cahaba Heights and Wald Park facilities through an agreement with the Vestavia Hills Youth Baseball (VHYB) Association.

Turner Food Systems, through its affiliate Center Point Concessions (which has since consolidated into Turner Food Systems), was awarded the concession agreement for the City of Center Point in February 2007. In February 2009, through a RFP, the City of Center Point chose to make a change and awarded a three-year concession agreement to a different vendor. In July 2010, the selected vendor, with no advance warning or notification, discontinued its concession operations with the City. The City of Center Point contacted the Turner Food Systems with an emergency request to resume concession operations. Turner Food Systems closed out the calendar year and recommended the City of Center Point resume operations of its facilities with volunteers. The City of Center Point agreed and volunteers began operation of those facilities.

In March 2008, the City of Homewood contacted Turner Food Systems to assume concession responsibilities for their youth baseball and football programs. Turner Food Systems entered into an open-end agreement with the City of Homewood Parks and Recreation Department.

In September 2010, the City of Vestavia Hills consolidated all concession agreements for Park and Recreation facilities. The City of Vestavia Hills awarded Turner Food Systems a 3-year agreement commencing on October 1, 2010 to be the exclusive food service vendor for all park and recreational facilities and the "I Love America" series co-sponsored by the Vestavia Hills Chamber of Commerce. This agreement is in effect at this time.

In June 2012, Turner Food Systems entered into an agreement with the City of Mobile to furnish food and beverages, manage and operate food and beverage services, including suite and hospitality tent catering at Ladd-Peebles Stadium. In January 2014, this agreement was extended until February 2016.

In January 2013, Turner Food Systems entered into an agreement with the City of Clay as the exclusive food service vendor for all park and recreation facilities.

In March 2013, the management of the Saenger Theatre was transferred back to the City of Mobile. At the request of the Office of the Mayor, Turner Food Systems became the official food and beverage provider for this 1,921 seat facility. The Saenger Theatre serves as a performing arts theatre and is the home of the Mobile Symphony Orchestra. Upon award of a management agreement to SMG, the food and beverage operation was transferred to SAVOR....Mobile, a division of SMG. Turner Food Systems serves as a third-party vendor under SMG for their managed facilities in Mobile to include the Saenger Theatre.

In July 2013, Turner Food Systems was awarded the concession agreement for all athletic facilities for the University of Louisiana at Monroe (ULM).

In July 2013, Turner Food Systems was awarded the Food and Beverage Concessions Operation Service of the Cramton Bowl Football Stadium in Montgomery, Alabama.

In May 2014, the City of Homewood amended the agreement with Turner Food Systems to include all Park and Recreation facilities including the Homewood Community Center.

In September 2014, Turner Food Systems entered into a three-year agreement with Shelby County, Alabama as the exclusive food service vendor for the Heardmont Sports Park.

In February 2015, Turner Food Systems entered into two-year agreement with the City of Calera as their food service vendor for their Park and Recreation facilities.

In February 2015, Turner Food Systems entered into a two-year agreement with Tuscaloosa County, as the food service vendor for the Tuscaloosa County Park and Recreation Authority (PARA) facilities. In association with the City of Tuscaloosa, this agreement includes the "Celebration on the River" held annually on the 4th of July.

In August 2015, Turner Food Systems was awarded the Food and Beverage Concessions Operation Service Agreement for the Cramton Bowl Multi-Purpose Facility in Montgomery, Alabama.

In July 2016, Turner Food Systems was awarded the concession agreement for all athletic facilities for the University of Louisiana at Monroe (ULM). Louisiana law requires a bid on all state agreements every three years.

Turner Food Systems, directly or through its affiliates, has the resources to provide quality, dependable food and beverage services, featuring brand recognizable products, to the patrons and guests of any facility or sporting event location.

MANAGEMENT CAPABILITY

Project Approach

Turner Food Systems designates all Vestavia Hills recreational facilities as a separate entity in our organization. Internal controls are established to ensure our standard operating procedures are adhered.

Due to our numerous agreements, resulting in a year-round schedule, our organization has an advantage in we order product in abundance to safeguard no shortage during events. Should there be a lull in activities at any of our locations, our logistics capabilities allow us to transfer excess product to other locations.

Additional Personnel

Turner Food Systems utilizes hourly food service professionals, under the supervision of our full-time staff, to operate most of its current facilities. This practice will continue with the award of the Parks food concessions service.

We also supplement our workforce with Non-Profit Organizations (NPO). This ensures sufficient staffing and maintains professional standards while providing local NPO groups the opportunity to raise funds for their specific civic organization. Depending on the size of an event, it may be practical to allow NPO groups the opportunity to provide services during events in the Parks.

With our agreements throughout Central Alabama, we have developed a database of food service professionals. With these personnel, referrals and the ability to contract with the primary food service provider in facilities in which we serve as a third-party vendor, Turner Food Systems has the resources for obtaining additional personnel for special functions.

Additional Offerings

Our plan is the concession stands to remain generic, offering familiar concession type items, i.e., the Nathans Famous Hot Dog, corn dogs, popcorn, nachos with cheese, etc. With our Branded Program, we will continue to emphasize the Nathans Famous Hot Dog as the centerpiece menu item.

For special or specific sporting events or any other scheduled events, we can utilize our specific franchises – such as Golden Rule BBQ – as the unique offering.

Our Maui Wowi Hawaiian Coffee and Smoothie franchise is under the franchisor management of Kahala Brands. This affords Turner Food Systems the opportunity to develop licensing agreements for the other Kahala Brands offerings. Those offerings include such brand recognizable brands such as Blimpie, Cold Stone Creamery, Pinkberry and TacoTime.

Buffalo Rock has granted Turner Food Systems authorization to utilize ICEE and Red Diamond Coffee and Tea in our Pepsi contract venues.

Our model is developed to provide patrons and guests with brand recognizable and specialty menu offerings.

Specialty Menu and Products

Turner Food Systems has incorporated products from its affiliates into other venues, and will continue to do so in the Parks. These specialty menu items for the catering, concession and food service operations, and special events we have available are as follows:

Management

Turner Food Systems will designate a Facility Manager for the Parks. The Facility Manager will ensure sufficient staffing, both full and part time personnel, to operate the Parks. The Facility Manager will ensure on-site management for all events.

Administrative functions, as with our other entities, will be consolidated at the Turner Food Systems level.

Permits / Licenses

Turner Food Systems has the appropriate and required licenses to perform business in the City of Vestavia Hills. This includes an active and current business licenses with the City of Vestavia Hills, Jefferson County and the State of Alabama.

Fiscal Services

Turner Food Systems has established and maintained an accounting system for its operations in accordance with Generally Accepted Accounting Practices (GAAP) consistently applied. Turner Food Systems will provide a monthly report outlining the gross receipts, the appropriate financial considerations, sales taxes paid and other information pertinent to the agreement and/or food concession operations. This report, including negative (null) reporting will be submitted by the 20th day of each month to coincide with sales tax reporting deadlines.

Turner Food Systems will continue to collect and remit to the appropriate governmental agencies the appropriate sales tax on all sales of product sold in the Parks. The collected sales tax is considered completely and separately apart from the exclusive rights fee.

Insurance

Due to the unique and expansive offerings of products through different points of sale (POS), Turner Food Systems, directly and through its affiliates, maintains several comprehensive policies of liability insurance.

For General Liability of our stadium, brick and mortar facilities, our policies are bound by the Boardwalk Insurance Group, through the agency of Kenneth Jeanes, 10849 Kinghurst Street, Suite 135, Houston, Texas 77099, telephone 713.987.3480, and facsimile 888.880.6393.

For Workers Compensation, our policies are bound by AmTrust North America, 800 Superior Avenue East, 21st Floor, Cleveland, OH 44114, telephone 216.328.6100, through the Boardwalk Insurance Group, through the agency of Kenneth Jeanes, 10849 Kinghurst Street, Suite 135, Houston, Texas 77099, telephone 713.987.3480, and facsimile 888.880.6393.

For the fleet vehicles necessary to deliver goods and products to the different park facilities and the point of sale concession trailers, the policy is bound by Progressive Specialty Insurance Company, Post Office Box 94739, Cleveland, Ohio 44101, telephone 800.444.4487 through the Boardwalk Insurance Group, through the agency of Kenneth Jeanes, 10849 Kinghurst Street, Suite 135, Houston, Texas 77099, telephone 713.987.3480, and facsimile 888.880.6393.

For the POS portables, carts, kiosks and fixtures, the policy is bound by The Travelers through the agency BBVA Compass Insurance Agency, Post Office Box 1467, Englewood, Colorado 80150, telephone 888.661.3938, and facsimile 877.552.6091.

These policies are established in accordance with industry standards at the time of this proposal. Should the City of Vestavia Hills deem these coverage amounts insufficient, Turner Food Systems will increase the insurance coverage to meet the required thresholds.

OPERATIONAL SERVICES

Turner Food Systems has the ability to generate additional revenue in the Parks. These additional revenue generators include:

Catering

Our organization has the resources to perform on-site catering in the Parks or other City of Vestavia Hills facilities. Our model is also designed for mobility. For special events or catering, patrons and guests can chose from the concession menu or for specific themed events, the full menu of Golden Rule BBQ, Boardwalk Fries, the Rocky Ridge Ice Company and Maui Wowi Hawaiian Coffees and Smoothies.

Automated Teller Machines (ATM) / Credit Cards

In our current facilities, Turner Food Systems offers guests and patrons the opportunity to make payment of their purchases with credit and debit cards. Guests and patrons making payment with credit cards seem to increase their overall ticket purchases. Turner Food Systems does not place a surcharge on the guests and patrons for such transactions.

Turner Food Systems offers ATM services to guests and patrons for designated events in other locations. Unless there is an agreement in place to prevent such, Turner Food Systems has the ability to provide these ATM machines for special events in the Parks.

Merchandising

Turner Food Systems has the ability to provide merchandise service management normally associated with entertainment venue operations. These services are primarily merchandise sales of event related material and novelties. This service includes coordinating all count in and out of merchandise with event promoters and tours or their designee, sellers, settlement and collections of appropriate fees.

Turner Food Systems has the ability to operate displays, sales counters and portable merchandise carts and/or temporary points of sale (on larger events) to offer approved merchandise on events that occur at the Parks to offer approved merchandise.

Marketing

Turner Food Systems will develop an aggressive marketing and promotion of the Parks in a manner that will maximize the use of the facilities (upon approval by the appropriate authority), area hotels and destinations. Food and beverage service is an integral part of the management and marketing of the Parks.

Operational Services

Turner Food Systems will develop operational services to include event coordination, production, staffing and servicing, facility operation, maintenance, security and parking services.

Should Turner Food Systems be afforded the opportunity to continue to provide food concessions in the Parks, our organization will take immediate steps to initiate operational services.

EQUIPMENT

Turner Food Systems utilizes additional points of sale to increase revenue. These points of sale include, but are not limited to, shaved ice carts and trailers, fresh squeezed lemonade carts, Minute Maid frozen lemonade carts, SuperPretzel carts, Funnel Cake Factory carts, Maui Wowi Hawaiian Smoothie carts, Oreo Churro carts, Dippin Dots and/or Mini Melts carts.

Turner Food Systems, with partners such as ICEE, J&J Snack Foods, Dippin Dots and Mini Melts, will continue to incorporate their unique offerings into the Parks. These offerings require specialized equipment, provided by the partner based on product and supply purchases.

Turner Food Systems has unique equipment, such as a shaved ice point of sale known as Polar Pete, to provide our specialty items for smaller or catered events and Mini Melts Ice Cream Vending Machine. With the permission of the City of Vestavia Hills, we can position a Mini Melts Ice Cream Vending Machine in the lobby of the Vestavia Hills Civic Center. This will allow the specialty ice cream at all events. For larger events, we will incorporate the additional points of sale.

Through our affiliates, Turner Food Systems has full-service mobile food units (MFU) which can be incorporated into a regular schedule. Placing these MFUs in the Parks during non-event periods will provide an additional source of revenue to the City of Vestavia Hills.

With the decision of the Jefferson County Health Department to designate Exchange Field as a separate entity from Wald Park (thus requiring a remodel of the facility), Turner Food Systems intends on developing and implementing a plan to transform the location into a full-service concession stand.

FINANCIAL PROPOSAL

Estimate of Income and Expenses

The estimate of income and expenses for the first year is subjective due to the changes of the business model for the Parks. Special events, such as tournaments, generate more revenue in a condensed period of time with than recreational activities. For the condensed period of time, expenses, such as staffing, can be managed more efficiently. For recreational activities, these same expenses become fixed thus reducing bottom line revenue.

In 2011, Turner Food Systems generated \$261,878.48 in revenue in the Parks. In 2015, this revenue decreased to \$218,901.47. This represents a decrease in revenue of \$42,977.01 (16.41%).

For January – July 2015, revenue was \$159,999.84. For this same period in 2016, the revenue was \$112,823.30, resulting in a decrease in revenue of \$47,176.54 (29.49%).

For January – July 2014, revenue was \$164,371.34. In comparison to this same period in 2016, this represents a decrease of revenue of \$51,548.04 (31.36%).

For January – July 2013, revenue was \$175,620.82. In comparison to this same period in 2016, this represents a decrease of revenue of \$62,797.52 (35.76%).

During this period, our expenses have remained constant.

This decrease in revenue is attributed to the loss of the travel baseball and softball tournaments at Liberty Park. In addition, with the expansion of the Vestavia Hills Youth Baseball to the Liberty Park Adult Complex, while our revenue has remained constant at the Parks, our expenses have increased due to the necessity for staffing the additional location.

Our partners, such as ICEE, require minimum purchases of products and supplies to substantiate their investment of equipment in the Parks. We must generate additional streams of income to return or increase revenue numbers to previous historical positions.

With our experience with the Parks, we hope to continue our relationship with the City of Vestavia Hills.





Concession Agreement For Recreational Facilities in Vestavia Hills, Alabama

This Concession Agreement is made as of the	day of	, by and between
Turner Food Systems, LLC, an Alabama corporat	tion, (CONTRACT	OR) and the City of
Vestavia Hills, an Alabama City (City) through the	ne Parks and Recre	ation Department and shall
be valid through September 30, 2019, subject to a	innual review by th	ne Parks and Recreation
Board as set forth in paragraph 2 (Agreement), be	elow.	

Recitals

- 1. The City wishes to provide items of food, concessions and non-alcoholic beverages to patrons of the following recreational facilities:
 - Wald Park
 - Exchange Field
 - Cahaba Heights Park
 - Liberty Park Adult Complex
 - Liberty Park Youth Complex
 - Liberty Park Soccer/Football Complex
 - Sicard Hollow Complex
 - Any other facility or complex owned or operated by the City, at its option, during the term of this Concession Agreement
- 2. The City wishes to enter into an agreement with a professional food services organization to provide those services and products.
- 3. The City wishes to participate to some extent in the profit stream from such operations.

Agreement

In consideration of the mutual promises and covenants contained herein, and other good and valuable consideration, the parties agree as follows.

1. Scope of Services

CONTRACTOR will provide operations of all concessions at the recreational facilities listed in paragraph 1 (Recitals) above. CONTRACTOR will be responsible for making available for purchase items of food, concessions and nonalcoholic beverages to the general public participating in or attending recreational activities. In return for this exclusivity, the selected vendor must provide the City with a revenue stream based on activity levels.

2. Annual Review & Termination

This Agreement will be reviewed annually by the City's Parks and Recreation Board. The City may, at its sole option, elect to not renew or terminate this Agreement, at any time, by providing CONTRACTOR with 30 days' written notice of its intent not to renew or to terminate this Agreement. Notwithstanding the foregoing, the City may terminate the Agreement at any time by providing seven days' written notice to CONTRACTOR for breach of this Agreement by CONTRACTOR.

3. Vendor Responsibilities

CONTRACTOR covenants and agrees to the following:

- a) To establish and maintain a specific set of detailed records reflecting the dollar amount of daily gross sales at each facility. These records will be separate and apart from any other accounts. These records shall be submitted monthly by Contractor for review by the Parks and Recreation Board no later than 5:00 pm on the second Monday of each month and will be retained by the Contractor for at least three years for audit purposes;
- b) CONTRACTOR or its designee shall be available at the request of the Parks and Recreation Board with at least 5 days' notice;
- c) CONTRACTOR or its designee must attend all Regular Park Board Meetings;
- d) Employing and training all of Contractors' employees necessary for the successful operation of the concessions operation;
- e) CONTRACTOR must maintain a current business license with the City of Vestavia Hills;
- f) Ordering, purchasing, receiving delivery of, and storing all consumable supplies and products necessary for the operation;
- g) Compliance with all existing laws and regulations relating to the preparation, handling, sale and disposal of food products and concession operations;
- Procuring and maintain, at all times the necessary, valid permits and licenses required by any laws and regulations for concessions operations. A copy of the Health Inspection report must be forwarded to the Director Parks and Recreation when obtained;
- i) Maintaining at all times storage, kitchen, service, and retail sales areas in a clean and sanitary condition to the sole satisfaction of the City's Parks and Recreation staff. Cleaning and waste removal from all food service areas to a central collection point outside of each stand shall be the vendor's responsibility. Parks and Recreation staff will do an inspection of cleanliness of all concession sites every three months or as necessary;
- Supplying any additional necessary equipment required for the preparation and serving of food and beverages;
- k) Preparation and service of all food, beverages and other items for consumption by the general public along with all necessary condiments;
- 1) The City's Parks and Recreation Department will notify CONTRACTOR of any and all events which are scheduled at any of the facilities listed in Paragraph 1 (Recitals), above;
- m) CONTRACTOR agrees to have each necessary concession stand fully operational and open for business at least 45 minutes prior to the first scheduled event at any and all facilities for which CONTRACTOR was notified by the Parks and Recreation Department;

- n) CONTRACTOR shall pay a fine of \$100.00 per occurrence if it is notified of an event by the Parks and Recreation Department and fails to perform as outlined in paragraph 2(m), above;
- o) Prior to ceasing concession operations for weather related conditions or any other reason at any facility, CONTRACTOR agrees to contact the Parks and Recreation Department and secure pre-approval from Parks and Recreation for the closing of operations;
- p) CONTRACTOR agrees the level of services in this agreement and cannot change (i.e. from prepared food to vending machines) without the City's approval.

3. Exclusivity of Agreement

CONTRACTOR will have exclusive rights to all concessions contingent upon the following:

- a) The continued, uninterrupted service to all locations, which includes making available, a broad range of food products to satisfy the needs of the public;
- b) The prompt submission of returns and sales reporting documents as required;
- c) Periodically, occasions will arise when fund raising projects are requested by various organizations. These will be coordinated and approved by CONTRACTOR, and the Parks and Recreation Superintendent.

CONTRACTOR shall have the exclusive rights to refer to and/or advertise as the "Official Concessionaire of the City of Vestavia Hills Department of Parks and Recreation" and/or the "Official Food Vendor of the City of Vestavia Hills Department of Parks and Recreation." CONTRACTOR will submit any promotional item or advertisement to the Parks and Recreation Superintendent for approval prior to release to the general public.

4. **Special Event Items**: CONTRACTOR acknowledges that, from time to time, the various sports organizations may desire special event items to be sold at the event, (i.e. food trucks, bake sales, etc.). CONTRACTOR acknowledges that nothing contained within this Agreement shall prohibit these Special Event Items nor shall the Special Event Items violate the Exclusivity provisions of this Agreement contingent upon the CONTRACTOR being notified of the Special Event Items by the Parks and Recreation Department not to exceed two weekends per sport per year.

5. Equipment Utilization

- a. CONTRACTOR may use the existing City owned equipment. The City will retain ownership of the equipment. CONTRACTOR will be responsible for routine maintenance and minor repairs (under \$250.00). Major repairs and/or equipment replacement will be the responsibility of the City unless due to gross neglect.
- b. CONTRACTOR may install additional equipment for use in the fulfillment of this agreement. CONTRACTOR will retain ownership of the additional equipment. CONTRACTOR will be responsible for all routine maintenance and repairs associated with this additional equipment. CONTRACTOR will be responsible for installation and removal of the additional equipment. Equipment that

- CONTRACTOR has placed in the facilities will become the property of the city at the end of this agreement should the agreement go full term.
- c. CONTRACTOR may use the existing City owned facilities as the commissary required by the Health Department of Jefferson County, Alabama for concession trailers associated with this agreement.

6. Approval Rights

The City of Vestavia Hills will have the following approval rights:

- a) The final approval of all policies and procedures relative to the operation and management of concessions;
- b) Final approval on the quality and retail prices of all products and services;
- c) Final approval of any change in the design, layout and location of all physical facilities and equipment for the operation;
- d) Final approval on which specific products will be sold at particular events in the facilities.

7. Menu

CONTRACTOR will provide a list of the items to be sold and the proposed selling price at the time of this Agreement's execution to be approved by the Parks and Recreation Superintendent and at any other time thereafter as requested by the Parks and Recreation Superintendent. CONTRACTOR agrees to modify said list of items to be sold or the proposed selling price at any time as determined feasible by the Parks and Recreation Superintendent.

8. Existing promotional agreements

The City currently has a promotional agreement (subject to annual competitive bidding) regarding soft drink sales. In return for exclusive use of said products, the City receives promotional considerations. CONTRACTOR agrees to abide by the terms of this agreement.

9. Fee

- a. CONTRACTOR agrees to pay to the City of Vestavia Hills the following percentages of the gross receipts from operations at the recreational facilities as compensation for the rights as the exclusive operator. These fees shall be paid to the Department of Parks and Recreation no later than 5:00 pm on the second Monday of each month:
- (a) 10% of all gross receipts which are within the range of \$0.00 \$350,000.00 for that calendar year;
- (b) 12% of all gross receipts once the yearly total gross receipts exceed \$350,000.00 and are within the range of \$350,000.01 \$550,000.00 for that calendar year;
- (c) 15% of all gross receipts once the yearly total gross receipts exceed \$550,000.00 for that calendar year.
- b. CONTRACTOR will also collect and remit to the City the appropriate sales tax on all sales of merchandise sold at the recreational facilities. The sales tax will be

considered completely separate and apart from the above mentioned fee structure. This sales tax will be remitted to the City of Vestavia Hills on a monthly basis.

10. Term of Agreement

The agreement shall not bind, nor purport to bind, the City of Vestavia Hills for any commitment in excess of the original agreement period stated above. The City of Vestavia Hills shall have the right, at its sole option, to extend the agreement for 2 additional 3 year terms. In the event that the City of Vestavia Hills exercises its options, all terms, conditions, and provisions of the original agreement shall remain the same and apply during the extension period.

11. Indemnification

CONTRACTOR agrees, at its own expense and without exception, to indemnify, defend and pay all damages, costs, expenses, including attorney fees, and otherwise hold harmless the City of Vestavia Hills, its employees, agents, servants and Board members from any liability of any nature or kind in regard to the delivery of these services.

12. Liability and Insurance:

CONTRACTOR will furnish the evidence showing the following insurance coverage to be in force throughout the term of the agreement: Certificate of Insurance acceptable.

- a) Due to the unique and expansive offerings of products through different points of sale (POS), CONTRACTOR, directly and through its affiliates, maintains several comprehensive policies of liability insurance.
- b) For brick and mortar facilities, the policy is bound by _____
- c) The limits of this policy are as follows:

h) CONTRACTOR will name the Vestavia Hills Parks and Recreation Department and/or the City of Vestavia Hills and/or any other requested entity as a named insured under its policies. Should the Vestavia Hills Parks and Recreation Department deem these coverage amounts insufficient, CONTRACTOR will increase the insurance coverage to meet the required thresholds.

13. Termination of Agreement

Either party may cancel this agreement with 90 days' notice for any reason by providing written notice of such cancellation. Either party may cancel the agreement with seven days notice for breach of agreement.

14. Assignment

CONTRACTOR shall not sell, assign, transfer or convey this agreement or any portion thereof without the prior written consent of the City of Vestavia Hills.

15. Conflict of Interest

CONTRACTOR covenants that it presently has no interest and shall not acquire any interest, directly or indirectly, which would conflict in any manner or degree with the performance of the services hereunder. CONTRACTOR further covenants that no person having any such known conflict of interest shall be employed or conveyed an interest, directly or indirectly, in the Agreement.

16 Independent Operator

CONTRACTOR represents itself to be an independent operator offering such services to the general public and shall not represent himself or his employees to be an employee of the City of Vestavia Hills. Therefore, CONTRACTOR assumes all legal and financial responsibility for taxes, FICA, employee fringe benefits, workers compensation, employee insurance, minimum wage requirements, overtime, etc., and agrees to indemnify, save, and hold the City of Vestavia Hills, its officers, agents, and employees, harmless from and against, any and all loss; cost (including attorney fees); and damage of any kind related to such matters. CONTRACTOR shall further understand that the City of Vestavia Hills cannot save and hold-harmless and or indemnify the operator and/or the operator's employees against any liability incurred or arising as a result of any activity of

the operator or any activity of the operator's employees performed in connection with the agreement.

17 Compliance with Laws

In connection with the furnishing of supplies or performance of work under the agreement, CONTRACTOR agrees to comply with the Fair Labor Standard Act, Equal Opportunity Employment Act, and all other applicable Federal and State laws, regulations, and executive orders to the extent that the same may be applicable and further agrees to insert the foregoing provision in all sub agreements awarded hereunder.

18 Invalidation of this Agreement

If any part of this agreement is rendered invalid for any reason, it shall not invalidate the remainder of the agreement, but the agreement shall remain in full force for the balance of the term.

- Fall 2016 Brian and Michael walked McCallum Park Brian asked Michael to submit an estimate to build trails without encroaching on VHHS property
- November 2016 -- Presenting the estimate to the Park Board for approval to send to council to as for funding to construct trails at McCallum Park.

Summary

In the fall of 2015 the city manager was approached by a group of people about mountain biking in Vestavia Hills. A conversation between Doug Brown, Tina Chancellor, Jeff Downes and Brian Davis was held to discuss options for the newly formed mountain bike team for 6th through 12th graders. The team is not affiliated with the AHSAA currently, but similar to lacrosse, is growing and has plans to affiliate at some point in the future. The team currently travels to Oak Mountain State Park to practice when they can. This option is feasible before daylight savings time, but when the time changes, the team doesn't get to practice during the week.

In the fall of 2015, the city had just acquired Altadena Valley Country Club, and it was offered as a place to practice during the week. The team was grateful for the space, however it wasn't ideal because it is flat. The discussion moved to creating or constructing trails at McCallum Park.

Michael Enervold of TrailVisions, LLC met with Doug, Tina and Brian at McCallum Park to walk the site. He was asked to put some information together on constructing some trails to potentially connect the high school to the park.

Doug Brown led the effort to discuss with Tyler Burgess of VHHS, but due to some potential erosion issues from the construction of the new parking lot, Tyler said the trail could not connect at this time.

Doug Brown also reached out to the Freshwater Land Trust (property owners along the creek in McCallum Park). FWLT were supportive of the trail construction, and they have since had a work day and improved the trail behind the Buckhead Subdivision.

Since there was going to be a cost to construct the trail, Doug Brown reached out to the Parks and Recreation Foundation to seek additional funding. The Foundation did not commit to funds, but was interested in know more as the discussions continued to move forward.

Brian Davis and Michael Enervold met in August 2016 and walked the trails that were under construction in Gardendale. From this conversation, they also met and walked at McCallum Park to discuss potential trails only on the property owned by the city and the FWLT. Brian asked for an estimate to construct potential bike trails as shown on the attached map. That estimate is also attached.

Brian met with parents of team members, Jenny and Jason Waters, and Lee Yielding to discuss the next steps. The next steps were to present the estimate to the park board for their support of the project, and if possible to ask the city council to fund the trails at McCallum Park.

The Brailsford and Dunlavey study that was completed a few years ago showed that nearly half of the respondents wanted additional trails or sidewalks in the city. This project would address a need that is currently unmet. The city is already constructing sidewalks, and have plans to continue into the future.

- Bookkeeper will establish an official financial record via QuickBooks (QB) for tax and financial reporting purposes and produce monthly financial statements to be reviewed by the sports board treasurer and president.
- Establish quarterly review for each sport boards (during season) of the financial statements by PRB.
- Explore implementing P-Card for each sports board to track all expenditures, provide
 documented approval process and automate journal entries into QB. Allow each sports boards
 to set limits and criteria for each P-card.
- With assistance from the CPA firm, including its bookkeeper, provide procedures on all donations, exemption requests and tax reporting.
- Establish standard tools and procedures; automate when possible.




- The treasurer of each sports board will work with the designated bookkeeper to insure proper communication and procedures are followed.

- The treasurer or president must be available to answer any emails, questions or phone calls from the bookkeeper or CPA if there are reconciling items to address.
- The sports board will work with VHPRA to meet the following objectives:
 - Provide online registration and spirit gear to eliminate as many cash and check payments as possible.
 - Automate transfer of money from on-line registration to bank account to create an electronic audit trail.
 - When possible use a debit or credit card (P-cards) instead of cash or checks for purchases to create an electronic audit trail.
 - Proactively identify and communicate any official filing required such as 1099, W-2, etc.. to VHPRA.

BK = Bookkeeper – New position SB= Sports Board QBO = QuickBooks Online or other cloud based accounting system Each SB = legal entity and EIN



Dear Jeff:

This correspondence is in response to your letter dated July 25, 2016 requesting my written opinion associated with two questions resulting from recent conversations whereby the Parks and Recreation Board (Park Board) is attempting to develop financial policies with participating Vestavia Hills sports organizations (sports organizations). The two questions posed in your letter were:

- 1. If the Park Board institutes mandatory financial policies for the participating sports organizations and offers an optional means to participate in a master 501c3 organization, does that create a component unit relationship between the City and any of the parties?
- 2. Is it appropriate for the various sports organizations to utilize the City's tax identification number in order to receive tax free purchases or for other financial purposes?

In order to answer your first question, the definition of a component unit is required. A <u>component unit</u> is a legally separate organization for which the elected officials of the City are "<u>financially accountable</u>". Financial data of a component unit generally requires separate presentation in the City's financial statements.

"Financially accountable" is defined as a situation whereby the City:

Appoints a voting majority of the organization's governing body and (1) is able to impose its will
on that organization (i.e. the City can significantly influence the programs, projects, activities, or
level of services performed or provided by the organization) or (2) there is a potential for the
organization to provide specific financial benefits to, or impose specific financial burdens on, the
City.

<u>Or</u>

2. Creates fiscal dependency (the organization must obtain City approval to determine or modify its budget, set its rates or charges, or issue bonded debt).

In the scenario you've presented in your first question, if the City Council or the City Park Board (whose members are entirely appointed by the City Council) does not appoint a voting majority of governing members of the master 501c3 or the individual sports organizations, no component unit relationship can be established under situation 1. And, as long as no fiscal dependency exists, no component unit relationship can be established under situation 2. So, assuming neither situation is met, the Park Board could institute mandatory financial policies and offer an optional means to participate in a master 501c3 without creating a component unit relationship.

Alternatively, if the City Council or the City Park Board appoints a voting majority of the governing members of the master 501c3 or the individual sports organizations and imposition of will or financial benefit/burden is present or fiscal dependency exists (as described above) then a component unit relationship will exist and the master 501c3's financial statements will qualify for presentation on the City's financial statements.

A component unit could have component units of its own if conditions described in the "Financially accountable" section above are met. The master 501c3 will not have component units if the aforementioned component unit criteria are not met. The City Council, the City Park Board or the master 501c3 will not appoint any of the governing members of the individual sports organizations. Also, no anticipated fiscal dependency exists between the City Council, the City Park Board or the master 501c3 and the individual sports organizations. As such, no component unit relationship will exist between the individual sports organizations and the City Park Board or the master 501c3.

In financial reporting, the concept of "materiality" exists. Simplistically, this is the threshold above which missing or incorrect information in financial statements is considered to have an impact on the decision making of users. If a component unit's financial statements are deemed immaterial to the City, then presentation on the City's financial statements may not be necessary. Materiality has an element of judgment, so, determining inclusion of a component unit could change at each financial statement presentation interval.

When determining component units, many times the ultimate outcome is a matter of professional opinion. Also, conditions can change that might alter relationships and component unit evaluations must be made annually to determine status.

Your second question relates to the use of the City's tax identification number by various sports organizations to receive tax free purchases. Section 40-23-4(11) and 40-23-4(15) of the Code of Alabama exempt municipalities from payment of sales and use taxes. No other organizations or entities should use the City's tax identification number to receive tax free purchases or any other financial purpose. Only the City should use this tax identification number for financial purposes.

Furthermore, charitable and nonprofit organizations and institutions have no special exemption from sales and use taxes in Alabama. They are required to comply with all the provisions of the laws, relating to the filing of returns, making payments of taxes required to be collected, etc. A mechanism does exist whereby a charitable or nonprofit organization can request a special act of the Legislature of Alabama for sales tax exemption.

The Trusted Grown-Ups Who Steal Millions From Youth Sports

WHITEHALL TOWNSHIP, Pa. — With downcast eyes and a microphone clenched in one fist, Brian Farley stood uneasily before nearly 400 children from the Tri-Boro Youth Soccer Club in eastern Pennsylvania.

He had stolen their money.

Mr. Farley, 55, the longtime treasurer of the all-volunteer, nonprofit club, had pocketed \$120,000 from the organization's bank accounts — money paid by parents so that their children could play.

A county court judge had ordered Mr. Farley to repent publicly to club members as part of his guilty plea, and so there he stood, in front of a throng of children sitting cross-legged on a grassy ball field waiting to play. The club's leaders were so fearful that an irate parent might charge or assault Mr. Farley that they hired security to maintain order.

"You try to be a good example to your children," Mr. Farley, whose son and daughter had played for the club, told the gathering. "What I did was one of the worst examples you could ever set for your children."

The youth sports boom in the United States, fortified by at least 30 million participants, has turned what were once homespun local leagues into quasi-professional enterprises with annual budgets that experts who track nonprofits say regularly reach \$250,000 — if not twice that.

Yet with the growth and development has come a long list of embezzlement and other corruption cases unfolding in a void of oversight and regulation and capitalizing on community trust.

Across the country, people who volunteered as treasurers and other officers for Little Leagues and sports clubs have been prosecuted for pilfering gobs of money from the coffers: \$220,000 in Washington, \$431,000 in Minnesota, \$560,000 in New Jersey, and so on, according to law enforcement authorities, league officials, experts on nonprofit

organizations and news reports.

The approximately 14,000 youth sports organizations in the United States take in annual revenue of about \$9 billion, according to the National Center for Charitable Statistics. Oversight of those sums is haphazard and not centralized, as there is no national agency in the country watching over youth sports.

Investigators and prosecutors in several states say embezzlement investigations involving youth sports have become common, almost always committed by unpaid board members who are highly regarded in their communities.

It is difficult to say whether the problem with embezzlement has worsened or if the growth of the leagues simply means more cases; there is no clearinghouse comprehensively tracking fraud in youth sports.

But investigators say the problem gets little public discussion even as, by some measures, there are signs of mounting cases. In the last five years, there have been hundreds of arrests and convictions in 43 states involving 15 sports, based on a study of news accounts and a database compiled by the Center for Fraud Prevention, an organization that aims to mitigate embezzlement in youth sports.

And those are only the cases that have become public.

Law enforcement officials estimate that they see only about half of the actual fraud in youth sports because organizations often cover up

smaller misappropriations to protect their reputations and preserve the ability to raise money in the future.

Some leagues have dissolved as a result. Most organizations survive, but they often must defer buying new uniforms; fixing up insufficient or dangerous fields; purchasing equipment; and financing capital projects.

Over all, the rate of fraud across the youth sports landscape, which includes thousands of prosperous travel teams, is probably small in scale given the vast scope of youth sports. In general, there is little data of any kind on how extensive embezzlement is among all nonprofit groups, let alone youth sports associations.

Yet watchdogs of the nonprofit industry note that youth sports organizations rarely put in place routine checks and balances, such as having multiple people in charge of the money, opening the door to fraud.

"People treat youth sports groups as social clubs and vest all their trust in one individual because they all know each other, but these organizations need to be treated like businesses with all the same internal and external financial controls," said James Martin, the Lehigh County district attorney, whose office prosecuted Mr. Farley's case. "Yes, everyone starts out with the best intentions, but then something usually goes wrong and no one is really watching."

A husband and wife were implicated in Michigan after a neighbor, an accountant whose sons played for the baseball league, joined the board and scrutinized the books, leading investigators to a case that uncovered \$300,000 in missing money.

In Winslow, Me. (population 7,794), there were three theft charges against members of volunteer sports clubs in a four-year span, including one person who was charged with <u>stealing from two</u> clubs.

In Wisconsin, a self-described soccer mom confessed to another soccer mom about taking money from the local club, only to discover she was <u>taking even more</u> money.

A woman in Vermont was convicted of stealing from a fund established to honor a dead child who had been a club member.

The exposure of embezzlement leaves communities thunderstruck and wounded at the revelation of neighbors stealing from neighbors, friends cheating friends. The children of the accused are often best friends with the children of the accusers.

"I couldn't comprehend having to tell the 700 kids in our entire membership that the money was gone and they couldn't play soccer anymore because their treasurer was a thief," Diane Miller, the Tri-Boro Youth Soccer Club's current treasurer, said last month, recalling Mr. Farley's arrest in 2013.

"I wanted to cry."

Skimming and Spending

While a preponderance of cases occur in suburbia, there have been dozens of arrests in farm communities and in big cities, too, <u>including Manhattan</u>.

"There's always a lot of cash involved in these organizations, and whenever there's cash, there's people eyeing the cash," said Tim Delaney, president and chief executive of the National Council of Nonprofits.

Erik Carrozza, the founder of the Center for Fraud Prevention, said: "Someone can easily skim 20 percent off the top and it will not be noticed for a while. Twenty percent for five years ends up being a lot of money."

That money gets spent in a variety of ways.

The police have reported that purloined money has gone to dog grooming, tickets to Walt Disney World, illicit drugs, a child's wedding, fishing trips, financial advice, N.F.L. and Major League Baseball tickets, lingerie, large deliveries of yard mulch, college loans and the interest on personal property being held in pawn shops.

Gambling debt has played a role in many cases.

Kevin Short, a lawyer who represented a hockey league official in Minnesota convicted of tax evasion after stealing more than \$400,000 from a league, said casino debt in fraud cases is so common now that investigators routinely check gambling habits when embezzlement is suspected.

"It's a standard question," Mr. Short said. "Since gambling came into Minnesota, we've been having problems and embezzlement."

Prosecutors and defense lawyers say that many others who have embezzled from youth sports organizations have done so because they were enduring a period of financial distress because of a divorce, a job loss or both.

From a work-release facility where he is confined after serving several months in jail, Kevin L. Baker said he stole more than \$200,000 from the Kent Little League in Washington State because he was trying to survive financially.

"I'm usually a trustworthy, honest person," Mr. Baker, who was the league's treasurer for seven years, said in a telephone interview last month. "I got in a bad situation, and when you're in a bad situation, you make decisions that you wouldn't normally make."

Since 2007, Mr. Baker, who coached his two sons in the league, had been a responsible volunteer at the league's many activities.

But in 2011, he lost his job, and his wife moved to Idaho with the couple's sons as part of a divorce. A grandfather who had helped raise Mr. Baker and had been a father figure also died around the same time.

To raise his spirits and to try something new — his grandparents had run a tavern — Mr. Baker decided to spend \$100,000 to buy a bar. The business started strong, then flagged precipitously.

Mindy Young, who prosecuted the case, said Mr. Baker had taken money from the Kent Little League in 271 transactions that included cashier's checks for as much as \$20,000. He knew that no one truly scrutinized the treasurer's books he had been doctoring.

But on Dec. 9, 2014, Kent's Little League president, Greg Whitcomb, went to an Office Depot and tried to use the league's A.T.M. card to buy \$18 worth of envelopes. The purchase was denied.

Based on the financial reports he had been receiving from Mr. Baker, Mr. Whitcomb believed the league had \$227,000 in bank and investment accounts. For a decade, the league had been soliciting donations and were finally on the verge of buying their own baseball and softball fields.

The Kent Little League was actually in debt, owing uniform manufacturers \$20,000.

"Worse, all the hard work by volunteers raising money for years was lost," Mr. Whitcomb said.

Mr. Baker turned himself into the Kent police.

"I felt so guilty; I couldn't sleep at night," said Mr. Baker, who has since been ordered to pay \$208,000 in restitution.

Last year, Mr. Baker, who had no previous criminal record, was sentenced to 22 months in jail.

String of Tell-Tale Signs

It often takes suspicious board members or officers to uncover the wrongdoing.

In the case involving Pennsylvania's Tri-Boro Youth Soccer Club, Mr. Farley's crime was not uncovered until a new club president, Tino Babayan, hired a lawyer to advise the club about various matters, including its finances. The lawyer quickly became suspicious of Mr. Farley's bookkeeping, especially when the club's retainer check bounced.

Mr. Babayan learned that 80 percent of the club's money was missing.

"Farley was basically paying off his bills and living as if the club's account were his own," said Steven Luksa, the assistant district attorney who prosecuted the case.

Mr. Farley declined to be interviewed last month, but his lawyer, George Heitczman, said that when his client lost his job working on Wall Street, he began making loans to himself from the club's account.

"He felt he was just borrowing, but that is a slippery slope," Mr. Heitczman said. "There were some payments back to the league, but Brian got so far behind."

Meanwhile, the club's board members, facing a host of unpaid bills, were suddenly desperate to keep Tri-Boro solvent.

Mr. Farley offered the club and prosecutors a restitution deal; the organization's leaders and the club's parent group balked.

Diane Miller, the new treasurer, had pored over the bank records and saw that the club's A.T.M. card had been used to pay for \$500 hairdressing appointments, hotel stays, wine and cigars.

"At that point, I wanted to find him," Ms. Miller said of Mr. Farley, "and spit in his face."

But the club, which needed the infusion of cash, took the deal, which amounted to \$55,000.

Mr. Farley received five years of probation and was ordered to make gradual, systematic repayments to Tri-Boro for the remainder of what he owed the club. Mr. Farley, who has remained in the Allentown, Pa., area, has been paying back the money at about \$225 a month and recently told another board member that he intended to pay back the roughly \$60,000 he owes the club.

Ms. Miller is skeptical. "We'll never see it all," she said.

Board members were forced to dip into their own pockets for \$200 or \$300 each to pay some of the club's most urgent expenses and keep it afloat.

This year, the club is thriving, with a growing membership roll.

Coaches and other club members have adapted to new policies mandating invoices and receipts for any reimbursable expenses, regardless of how small the sum. Two board members are also required to extensively review the club's books monthly.

"We can't let anything go unexamined," Ms. Miller said.

Like the Tri-Boro Soccer Club, the Kent Little League in Washington had to run on a skeleton budget before it rebounded in part because several local sponsors donated time and money when they heard of Mr. Baker's theft. A software company that had been working on a new league website chose to finish and install the website for free, allowing valuable registration fees to flow into the league's bank accounts faster.

Still, the Kent Little League misses the more than \$200,000 it intended to spend on new fields, cash Mr. Whitcomb knows the league will probably never recoup.

As Mr. Whitcomb retrieved the mail at home not long ago with his 15year-old son, he saw an envelope from Mr. Baker.

"I smirked and handed it to my son and said, 'Here's the first restitution payment to your Little League,'" Mr. Whitcomb said.

Inside the envelope were two checks for \$14 and \$11.

Reluctance to Commit

There is another common thread to many fraud cases in youth sports: the scarcity of people running them, which significantly hampers the necessary oversight.

Overscheduled, working parents are hesitant to commit the time to serve on boards. And no one wants to be an organization's treasurer, which is the most tedious, thankless job.

"People are always asking, 'Can I pay to get out of my time working in the concession stand?'" Mr. Whitcomb said.

Many affluent organizations have turned to paying the officers of their boards of directors as an incentive to serve. Others are hiring bookkeepers. Crime or fraud insurance designed specifically to cover youth groups is gaining in popularity.

There are groups that have tried to fill the void, like the National Alliance for Youth Sports, a Florida-based nonprofit and youth sports advocate that helps train coaches and administrators. Little League offers guidelines to community leagues and training and information for volunteers.

Nonetheless, in recent years youth sports officials have found themselves forced into unforeseen roles: crime investigator, mediator and crisis management specialist.

"You start out wanting to help kids and you end up doing things you never thought you'd have to do," said Mr. Babayan, no longer the Tri-Boro Soccer Club president.

When Mr. Farley concluded his 73-second apology to hundreds of young soccer players, Mr. Babayan, who had exposed Mr. Farley's embezzlement, was standing a few feet away. As Mr. Farley dropped one arm and uncomfortably raised his gaze to the crowd, Mr. Babayan diplomatically stepped forward to grasp the microphone from Mr. Farley's clenched fist.

The children appeared confused. The parents were miffed. An awkward silence enveloped the grounds.

"No one had ever seen anything like that before," Mr. Babayan said.

Eventually, the players stood and separated into groups. It was time to play.

Mr. Burnett,

In accordance with the Concession Agreement for Recreational Facilities for the City of Vestavia Hills between Turner Food Systems, and the City of Vestavia Hills, the rebate fee / revenue share for October 2016 is enclosed.

Gross revenue receipts for concession operations at the City of Vestavia Hills Park and Recreation Facilities for the month of October 2016 were \$19,396.20. Based on these revenue receipts, the rebate fee / revenue share to the City of Vestavia Hills Parks and Recreation Department is \$2,909.43.

Gross revenue receipts for operations at the City of Vestavia Hills Park and Recreation Facilities year-to-date are \$160,887.17. The rebate fee / revenue share to the City of Vestavia Hills Parks and Recreation Department year-to-date is \$24,133.08.

Spreadsheets reflecting the daily revenue, sales tax collection and rebate fee / revenue share by facility and a cumulative summary are enclosed.
