# STANDING ANNEXATION COMMITTEE MEETING AUGUST 29, 2018 MINUTES

The members of the Standing Annexation Committee met on August 29, 2018 at 4:00 PM, with Kimberly Cook presiding. The meeting was held at the Executive Conference Room, Vestavia Hills City Hall.

The following members were present: Kimberly Cook, Acting Chairman; Conrad Garrison, acting secretary; Scott Key; Johnnie Evans, representing Chuck Nagle. City Engineer, Christopher Brady, was also present. The following members were absent: Chuck Nagle, George Pierce, Chairman, Jeff Downes, Steve Bendall and Rebecca Leavings.

Kimberly Cook called the meeting to order.

The minutes from the April 5, 2018 meeting were presented for approval. Mrs. Cook noted an amendment to remove reference to the quorum, as the committee is not a voting committee and has no quorum. Motion to approve minutes, as amended, was made and seconded. Motion carried unanimously on a voice vote.

The Committee reviewed and discussed the following annexation petitions:

- Annexation 2532 Skyland Drive; Jason and Laura Sparks
- Annexation 3421 Coventry Drive; Barbara French
- Annexation 3531 Valley Circle; Alan and Patricia Foster
- De-Annexation 3961 Briar Oak Drive; represented by Frank Galloway III, attorney

Property owners or their representatives were present for all cases.

Discussion ensued on the annexation petitions.

Mrs. Cook asked Jason and Laura Sparks (2532 Skyland Drive) if they had been made aware of the private drainage pipe issue and whether they had obtained a cost estimate for its repair. Mr. and Mrs. Sparks said they had not obtained an estimate, but understood the drain pipe fix would likely be a condition of annexation. Mr. Brady stated the pipe condition was not currently causing a problem to adjacent property owners. Mr. Brady said he had discussed the public portion of the pipe problem with Jefferson County and the County indicated a willingness to partner (typically, 50/50) with the City to repair the pipe, which is not on the current list of Vestavia Hills public pipe projects. Mrs. Cook told Mr. Brady it would be important to have a cost estimate for this repair before the matter came to the Council. Mrs. Cook noted the lower-than-median value of the property. Mr. Sparks indicated that, since their purchase, they had improved the home, adding hardwood floors throughout, updating the kitchen and landscaping. Mrs. Cook noted that a nearby

property, already located in Vestavia Hills, which was similar in size, had recently sold for \$320,000.

Mrs. Cook spoke to Scott Brown, the attorney-representative for 3962 Briar Oak Dr. and stated that the City Council will make the decision based on the best interests of the City. Mrs. Cook noted the significant amount of property taxes provided by the property to the City and school system and that the only advantage to the City, based on the City department reports, would be the removal of this address from the garbage collection schedule.

Mr. Garrison also reminded Mr. Brown that a signed affidavit by the owner needed to be submitted before the case can move forward. Mr. Brown stated it would be submitted by the end of the week.

There being no further business the meeting was adjourned.
