#### WORK SESSION

#### MARCH 30, 2020

The City Council of Vestavia Hills met in a special work session on this date at 5:00 PM, following publication and posting pursuant to Alabama law. Due to the COVID-19 pandemic, in coordination with a Proclamation from Governor Ivey and pursuant to orders from the Jefferson County Health Department Official requiring social distancing along with limits of attendees, this meeting was held with a portion of the City Council digitally attending the meeting via remote computer locations utilizing a Zoom.com application. Staff and general public/audience members also were invited to attend via Zoom.com following publication pursuant to Alabama law. Mayor Curry called the meeting to order and the City Clerk checked the roll with the following:

The Mayor called the work session to order.

#### **UPDATE ON COVID-19 PANDEMIC**

Mr. Downes stated that he previously sent out information regarding the COVID-19 pandemic and the County's efforts to "flatten the curve" by requesting a partial shutdown of the County both in schools and businesses. He gave a brief overview of the City's financial position at the FY midpoint and indicated that they will hold off any decisions on the Community Building until May. He added that with the time constraints on the Crosshaven Drive project, they will bring that to Council for approval by unanimous consent at the meeting tonight beginning at 6 PM.

Mr. Pierce agreed that the decision to hold off of the Community Building needed to be held off with the East Street Sidewalks and the Crosshaven Drive project moving forward. He stated that there needs to be more study on the alternates with the Community building and more discussion.

Mrs. Cook and the other Councilors concurred.

#### **INFRASTRUCTURE AND COMMUNITY SPACES PLAN**

Raynor Boles, Construction Manager from TCU, gave detail from the opening of the Crosshaven Drive bid opening. He explained the bids and their recommendation to accept the lowest responsible bidder.

Mr. Downes stated that the final numbers came out with a net of \$400,000 above the budget.

Mr. Upchurch reiterated that the Crosshaven bid came in more than \$400,000 over budgeted numbers, but the scope had also changed significantly, to include relocation of utilities, a duty the County delegated to the City, and for which the City received compensation.

Extensive discussion ensued as to the detail of the Crosshaven Drive project, the delay of the Community Center, the need to keep up-to-date accounting numbers of each project and hold to budgets, concern of overruns, etc.

The question was asked if the pandemic will slow construction. The Mayor stated that construction projects are considered essential businesses, so, hopefully, it will not have any affect as the weather improves and construction ramps up.

There being no further business, the work session adjourned at 5:50 PM.

Jim Bob McAllister led the invocation followed by the Pledge of Allegiance.

#### ANNOUNCEMENTS, GUEST RECOGNITION

- Mayor Curry announced that this was the first "digital" meeting of the Vestavia Hills City
  Council to be held via teleconference and by video using Zoom.com application. He
  explained that this is being done pursuant to a Proclamation by the Governor of Alabama
  and orders of the Jefferson County Department of Health Officer that limits the attendees
  of the meeting to ten and social distancing.
- Mrs. Cook reminded everyone that there is an upcoming vacancy of the Vestavia Hills Board of Education. Deadline for application is close of business on April 1<sup>st</sup> and

- interviews would be held on April 6. Due to the pandemic, applications may be emailed to the City Clerk.
- Mrs. Cook stated that the Board of Education had met earlier today. She stated that the meeting there was also live streamed but she was unable to attend, because she did not receive a notification from the Board of Education Secretary. She stated that she checked with a board member and learned business included plans for the continuation of the school year. She stated that the plan is that the school year will continue until May 21, the last day of the school year, which is unchanged. As soon as approval is given by the state of the Board's plan for continuation of education, they will proceed to complete the school year and receive credit for the academic year and allow graduation of seniors. The plan will be submitted this week along with a rollout for parents to understand how this will occur. Mrs. Cook stated she asked how business shutdowns due to the virus was likely to affect their budget and was told that the school system would not likely feel much of an impact this year, but next year is unknown because the state's budget might change due to the impact of the business restrictions on the economy.
- Mr. Pierce stated that in the past he remembers a snowstorm that required a quorum of the Council for a meeting, and that he and two other councilors were picked up by the VHPD, and brought to City Hall where the meeting was opened and closed.
- The Mayor explained that the BZA met last Thursday by video-conference and that this might be the practice for future meetings.
- Mr. Weaver stated he has spoken to Will Ainsworth, Lt. Governor of Alabama, who has
  asked Gov. Ivey to do more around the state to keep families and communities safe from
  this virus. He indicated that personal responsibility of each family will go a long way into
  fighting this spread.

#### **CITY MANAGER'S REPORT**

- Mr. Downes stated that he will be delivering the City's Financial Reports on behalf of Mr. Turner through the month of February 2020. He showed the documents and explained the balances as detailed. He indicated that the City is in a good position, as of the date of this report, which is one month short of the mid-year balances.
- Mr. Downes indicated that there is also enough annual surpluses to have over \$15.3 million between the City's emergency reserve along with the City's unassigned fund. He stated the City is presently in a good situation, which should help to carry us through this difficult time.
- Mr. Pierce asked if employees have received enough protection and training in how to protect themselves and their families from the virus. Mr. Downes explained the City's safe policies for providing customer service during this tough time.
- Mrs. Cook thanked Mr. Downes for the models he sent to the City Council concerning the City's financial position during this pandemic and mentioned importance of the reserves. She stated that the Board of Education had indicated this is also important for the stability of the school system. She stated that the merchants of the City have become creative in providing curbside services and mail delivery--anything to keep businesses afloat.

#### **COUNCILOR REPORTS**

- Mr. Pierce stated that Karen Odle, President of the Chamber of Commerce, has expressed
  concerns regarding the smaller businesses within the City, and the Chamber has provided
  helpful resources, during this time.
- Mr. Weaver stated that the Planning and Zoning Commission will meet in regular session on April 9. He stated that they will probably have to meet by tele-conference because of the situation.
- Mr. Head stated that all Parks and Recreation facilities remain officially closed.

He stated that TCU had reviewed the bids, value engineered wherever possible, and recommended the acceptance of Tortorigi Construction Inc. He explained that, overall, the project was about \$400,000 over the anticipated price once all the predetermined funding had been exhausted.

Discussion ensued that the project was over estimated costs and continued overruns would make decisions making harder on the remainder of the Community Spaces projects. Mr. Upchurch pointed out that the scope of the project increased, as the City took on work on behalf of the County, in order to expedite this project. If the City were to wait longer or decide to rebid, the costs will only go up.

Mr. Pierce asked when the construction would begin and end.

Mr. Downes stated they hope to mobilize soon and Mr. Brady stated that the contract is for 12 months.

Mrs. Cook asked about timing concerns, with area businesses trying to catch up in sales, going into the end of the year, once this pandemic allows the re-openings. She asked that the construction not hurt those efforts.

Mr. Downes stated he will work with everyone to try to prevent any issues with businesses.

# AN ORDINANCE NAMING THE NEW SWIM/POOL FACILITY LOCATED AT WALD PARK AS THE VESTAVIA HILLS AQUATIC COMPLEX

**WHEREAS**, in 2019 and 2020, the City of Vestavia Hills enacted the Infrastructure and Community Spaces Plan which included demolition and construction of a new swim/pool facility in Wald Park; and; and

**WHEREAS**, on March 17, 2020, the Vestavia Hills Parks and Recreation Board voted to name the new pool facility the "Vestavia Hills Aquatic Complex;" and

**WHEREAS**, in an interoffice memorandum dated March 17, 2020, the Public Service Director advised the City Manager of the Board's action and asked that the City Council consider formalizing the name of the facility by way of Ordinance, a copy of which is marked as Exhibit A, attached to and incorporated into this Ordinance Number 2924 as though written fully therein; and

**WHEREAS**, the Mayor and the Council agree it is in the best public interest to name the new facility the "Vestavia Hills Aquatic Complex" as recommended by the Parks and Recreation Board.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VESTAVIA HILLS, ALABAMA, AS FOLLOWS:

- 1. That the newly constructed swim/pool facility located in Wald Park shall be known and designated as the "Vestavia Hills Aquatic Center;" and
- 2. Each reference to such pool facility in an ordinance, map, resolution, document, record or other paper of the City of Vestavia Hills shall be deemed to be a reference to "Vestavia Hills Aquatic Center."
- 3. This Ordinance shall become effective upon approval and adoption and its publication and/or posting as required by Alabama law.
