The Mayor called the work session to order.

#### <u>UPDATE ON COVID-19 PANDEMIC – VIRTUAL MEETINGS</u>

The Mayor stated that there has been recent conversations about the City Council meetings utilizing Zoom and the protocols that should be used in order to ensure that anyone interested may be heard by the Council.

Discussion ensued as to the various options and the City Manager indicated that the meetings have worked well in the Chambers using technologies but others can be utilized. It was suggested that the general public could "pre-register" comments to be read at the Council meeting along with texting in real time.

The Mayor stated that there hasn't been anything of much interest on the last two agendas, however, on the 27<sup>th</sup> the new Board of Education applicant will be appointed and there'll be other issues as time progresses.

The Council concurred that the announcement for the meeting of the 27<sup>th</sup> would include provisions to allow residents to pre-register comments and/or text in real time with the City Clerk.

#### **BOARD OF EDUCATION APPOINTMENT**

Mayor Currey opened the floor for any Councilor who wished to speak on the issue of the applicants that are applying for the vacancy on the Board of Education.

Discussion ensued among Councilors on the desirable qualifications for the next member, the excellent pool of candidates that applied for the vacancy, the schools each applicant's child might attend, etc.

#### **LIGHTS ON MONTGOMERY HIGHWAY**

Mr. Downes address the update of the malfunctioning lighting along Montgomery Highway. He reminded the Council that the lights had been recently replaced with more modern LED lighting but the poles and the wiring were not replaced. He stated that when a problem occurs, the lights begin to "strobe" up and down the highway and the power has to be cut. He stated that they have found a good contractor that feels they can address the situation within the budget, however, they have to wait on the contract to have the time to fix it.

Mrs. Cook asked about the cost of repairs.

Mr. Downes stated that it's just under \$50,000 which is under the threshold for a bid.

#### RESERVE FUND REINVESTMENT

Mr. Downes stated that he was informed by Mr. Turner and the City's investment of Reserve Funds is about to mature and quotes show that further long-term investment could result in negative interest because of the current market. He stated that Mr. Turner had recommended investing the funds in short-term investments for about a year and reevaluate at that time to see if market conditions are better.

Mr. Downes updated the Council on sanitation bids which should be released tomorrow. He stated that the bid will contain several alternates for the Council to decide in order to set up for an October 1 implementation.

Mrs. Cook stated that there was a littering situation in her neighborhood that was fed by rumors that the drivers could not exit their vehicles to pick up any spillage. She stated that she understands from the contractor that they have committed to picking up any spillage and recommended that residents report through the Action Center.

Mr. Pierce commended the City News that's released via email. He stated it informed residents on the new playground equipment and has gone so far in depth on other information that he found it very informative.

Cinnamon McCulley, the City's Communication Specialist, stated that over 600 residents have subscribed to the City News and she's continuing to see it grow.

There being no further business, the work session adjourned at 6:45 PM.



The project would have 3,600 sq. ft of retail and 7,750 sq. ft of office space. The lot would not have it's own access but instead would share between Martin's BBQ and Philadelphia Baptist Church. 




Figure 4: Future Land Use Map
