- Mrs. Cook announced that school starts on August 20.
- Mr. Pierce welcomed to the meeting Chamber Board member, Rachel Patterson via Zoom.
- Mr. Weaver announced that the Planning and Zoning regular meeting will be Thursday at 6 PM both in person and via Zoom.

- Mr. Head announced that the Parks and Recreation Board Work Session will begin at 11 AM on Friday, August 21 in the Council Chambers with the Zoom option.
- David Harwell, candidate for City Council Place Number 3, introduced himself and asked for support in the upcoming election.
- Paul Head, candidate for City Council Place Number 3, introduced himself and asked for support in the upcoming election.

PROCLAMATION

Mrs. Cook stated that the OLLI folks are also zooming in tonight in honor of this and she welcomed them.

Ms. Sandi Wilson, Parks and Recreation Superintendent over Seniors and Programming, announced a drive-thru event on August 21 honoring senior citizens. She stated that it will be great event.

CITY MANAGER'S REPORT

- Mr. Downes stated that this Friday, August 14 beginning at 6 PM, there will be a celebration of the opening of the Cahaba Heights Park and everyone is invited. ORDINANCE NUMBER 2814-A

Ordinance Number 2814-A – An Ordinance To Amend Chapter 16.5 Entitled "Telecommunications," Article III Entitled "Small Cell Technology Facilities," Of The Vestavia Hills Code Of Ordinances And To Amend Ordinance Number 2814 To Adopt Regulations For Small Cell Technology Facilities In The City Of Vestavia Hills, Alabama (public hearing delayed until August 10)

MOTION Motion to approve Ordinance Number 2814-A was by Mr. Weaver, seconded by Mr. Head.

The Mayor announced that two Councilors are recusing themselves from consideration of this Ordinance because of family connections to representing attorneys of the various communication companies. Mrs. Cook and Mr. Pierce recused.

Mr. Downes explained that these amendments do not change the substance of the previous Ordinance. He stated that the request came from Alabama Power to show that the intent of this small cell regulations does not apply to their operational electrical utility performance in the City. He stated he has worked with them over the language and ultimately agreed on it. Once submitted, AT&T approached the City with concerns over the verbiage. In working with both companies and Mr. Boone, a compromise was reached with a letter from Alabama Power's letter as an exhibit, allows this to finally come forward. Representatives from both companies are present in case there are any concerns.

Terri Williams, Regional Director for AT&T, thanked the Council and Mr. Downes for working with them on this Ordinance. She explained that they don't see how this affects Alabama Power but this revised Ordinance poses no issues with AT&T.

Chad Pilcher, attorney representing Alabama Power, explained the reasons for the recusals of the two Councilors and explained that they do use wireless units in their communications and don't want issues down the road.

The Mayor opened the floor for a public hearing. There being no one else to further address the Council, the Mayor closed the public hearing and called for the question. Roll call vote as follows:

Ordinance Number 2940 – An Ordinance Authorizing The Mayor And City Manager To Execute And Deliver A Supplemental Agreement No. 2 With Gresham Smith & Partners As Architect And Engineer For The Pedestrian Bridge Over US Highway 31 (public hearing)

Christopher Brady, City Engineer, stated that this is additional funding to wrap up the design of the proposed pedestrian bridge. He explained the extra work required by the architect to coordinate utility coordination and other required changes. ALDOT plans to bid the project in November.

The Mayor stated this is good news and he hopes this bridge moves forward.

ORDINANCE NUMBER 2941

AN ORDINANCE GRANTING A CONDITIONAL USE APPROVAL FOR A HOME OCCUPATION

WHEREAS, on October 16, 2000 the City Council of the City of Vestavia Hills, Alabama approved and adopted Ordinance Number 1838 creating and establishing a P.U.D. (planned unit development) classification; and

WHEREAS, on February 19, 2001 the City Council of the City of Vestavia Hills adopted and approved Ordinance Number 1864 to rezone 3,350 +/- acres from multiple Jefferson County and Vestavia Hills zoning classifications to Vestavia Hills P.U.D.; and

WHEREAS, Section 709.5.A.1.b of Ordinance Number 1838 classifies a "home occupation" permitted only as a "Conditional Use" and

WHEREAS, Timothy Boyne has submitted application for conditional use approval for a home occupation to be operated in the residence located at 4129 Vestview Drive, Vestavia Hills, Alabama located in the Liberty Park P.U.D.; and

WHEREAS, Mr. Boyne has indicated in his application for conditional use approval that he will operate a consulting business out of his home pursuant to the specifications of a home occupation; and

WHEREAS, a copy of said application dated May 18, 2020 is attached and hereby incorporated into this Ordinance Number 2941.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VESTAVIA HILLS, ALABAMA, AS FOLLOWS:

- 1. Conditional Use Approval is hereby approved for Timothy Boyne for a home occupation as described in the above-referenced application for their residence located at 4129 Vestview Drive, Vestavia Hills, Alabama located in Liberty Park P.U.D. subject to the provisions in Article 9 of the Vestavia Hills Zoning Code outlined as follows:
 - (1) "Home occupation is defined as any use customarily conducted entirely within a dwelling and carried on solely by the inhabitant thereof, and which use is clearly incidental, accessory, subordinate and secondary to the use of the dwelling for dwelling purposes, and does not change the character of the

- dwelling itself or any part of parcel of property in the neighborhood surrounding said dwelling.
- (2) Home occupations shall be conducted only in the main dwelling building on the lot. No more than twenty-five percent (25%) of the said dwelling may be used for a home occupation.
- (3) There shall be no public display of goods and absolutely no commodities sold on the premises; no customer, client or employee traffic to, at or near the residence that is generated, directly or indirectly, by said home occupation. There shall be no pickup or deliveries to the residences that are related to said home occupation whether directly or indirectly.
- (4) No sign may be attached to the dwelling or any part of the real estate advertising any home occupation.
- (5) No home occupation or profession shall be permitted if such occupation creates noise, odors, vibrations or traffic which interferes with the residential qualities of the neighborhood insofar as health, safety, morals, convenience and general welfare are concerned.
- (6) In order to be a permitted home occupation or profession, the use must be one which is habitually, customarily and commonly established as a reasonable incidental, accessory, subordinate and secondary use.
- (7) Operation of any and all other business of any nature in residential zones is expressly prohibited; and
- (8) The activity carried on as home occupation shall be limited to the hours between 7:00 AM and 10:00 PM."
- Conditional Use Approval is further conditioned upon and subject to all applicable private and restrictive covenants attached to the property located at 4129 Vestview Drive, Vestavia Hills, Alabama located in the Liberty Park P.U.D.
- 3. A City of Vestavia Hills Business License shall be issued upon application and payment by Mr. Boyne working to the rules and regulations outlined in the Vestavia Hills Business License Code and shall be renewed each year that the

- home occupation is operated from the location at 4129 Vestview Drive, Vestavia Hills, Alabama located in the Liberty Park P.U.D.
- 4. At any time should Mr. Boyne vacate the premises located 4129 Vestview Drive, Vestavia Hills, Alabama, discontinue or relocate his business, this conditional use approval shall be nullified and said Ordinance Number 2941 shall be automatically repealed.

Greene County Water and Sewer Authority,* 77 So.3d 1166 (2011), in the form of an ordinance or resolution, *Van Antwerp, et al v. Board of Commissioners of City of Mobile*,217 Ala. 201, 115 So. 239 (1928); that the contract be signed by the Mayor as required by Title 11-43-83, *Code of Alabama, 1975*; and that the contract be signed by the City Manager as required by Title 11-43-21(7), *Code of Alabama, 1975*; and

WHEREAS, Title 11-47-24(b), *Code of Alabama*, 1975, provides that all municipal corporations of the State of Alabama are authorized to contract at governmental expense for policies of liability insurance to protect the City and its employees in the course of their employment; and

WHEREAS, Title 11-47-190, *Code of Alabama*, 1975, provides that municipalities may be liable for negligence; and

WHEREAS, on or about November 19, 2016, Stephanie Manakides was walking over and along a public sidewalk located at or near 1300-1304 Badham Lane in the City of Vestavia Hills, Jefferson County, Alabama; and

WHEREAS, Stephanie Manakides fell on the public sidewalk at said time and place and sustained what she describes as serious, severe and permanent injuries to her body including a broken arm and injured shoulder; and

WHEREAS, the case of *Stephanie Manakides v. City of Vestavia Hills*, *Alabama*, *et al*, (hereinafter referred to as "lawsuit") was filed on November 16, 2018 as civil action number 01-CV-2018-904625.00 in the Circuit Court of Jefferson County, Alabama, and said lawsuit is presently pending; and

WHEREAS, Stephanie Manakides, by and through her attorney of record, has offered to settle the lawsuit for the sum of Twenty-five Thousand Dollars (\$25,000.00), which is an amount less than the deductible on the City's general comprehensive liability policy; and

WHEREAS, attorney J. Bentley Owens, III, legal counsel of record representing the City in the lawsuit, and City Attorney Patrick H. Boone, by letter dated August 19, 2020, have recommended that the City accept the Plaintiff's offer of settlement in the amount of Twenty-five Thousand Dollars (\$25,000.00); and

WHEREAS, a copy of the letter, dated August 19, 2020, from City Attorney Patrick H. Boone and J. Bentley Owens, III is attached hereto, marked as Exhibit A and is incorporated into this ordinance by reference as though set out fully herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VESTAVIA HILLS, ALABAMA, AS FOLLOWS:

- 1. The recitals set forth in the premises above are hereby incorporated into this ordinance by reference as though set out fully herein.
- 2. The City Manager and Mayor are hereby authorized and directed to settle the lawsuit described in the premises above pursuant to the written recommendation of City Attorney Patrick H. Boone and special legal counsel and attorney of record, J. Bentley Owens, III, pursuant to the terms, provisions and conditions hereinafter set forth below.

- **3.** The total amount of settlement to be paid by and/or for and on behalf of the City of Vestavia Hills, Alabama ("City") shall be the sum of Twenty-five Thousand Dollars (\$25,000.00).
- **4.** The lawsuit against the City and all Defendants named in the lawsuit shall be dismissed with prejudice.
- 5. The Plaintiff shall forever discharge and release all of the named Defendants in the lawsuit from any and all damages arising out of the incident made the basis of this lawsuit and shall make no claim for any attorney fee whatsoever against the Defendants. Plaintiff shall also satisfy all subrogation liens arising out of the accident and shall indemnify and defend the City against any and all claims for reimbursement, whether medical or otherwise.
- **6**. The Mayor and City Manager are hereby authorized and directed to pay the funds described in section 3 above and to take any action and execute and deliver any and all documents necessary to effectuate said settlement.
- 7. The settlement authorized herein is a compromise, adjustment and settlement of a doubtful and disputed claim and the payment of the sum recited in section 3 above is not an admission of liability by the City of Vestavia Hills, Alabama or any of its public officials or public employees and the City expressly denies liability.
- **8.** If any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect notwithstanding such holding.

WHEREAS, the notice advertised by the City of Vestavia Hills inviting sealed competitive bids for the collection and disposal services for single-family residential garbage, trash, recyclables, leaves and storm debris requested that bidders submit bids for several different levels of service; and

WHEREAS, four different companies responded by submitting sealed bids; and

WHEREAS, AmWaste, LLC submitted its bid on May 28, 2020 and included bids for several different levels of service as requested by the City; and

WHEREAS, the City Council found and determined that the bid submitted by AmWaste, LLC was the lowest and most responsive bid submitted; and

WHEREAS, the City Council approved and adopted Resolution Number 5255 on July 13, 2020, which accepted the bid submitted by AmWaste, LLC upon the condition that the City Council would withhold the determination of the level of service to be provided by said Contractor until the Community Engagement Process had been completed; and

WHEREAS, the Community Engagement Process has now been completed; and

WHEREAS, the City Council finds and determines that the best level of services are those services more particularly described in Section F on page 28 of the Bid Documents and more particularly described in Section 6 of this Contract; and

WHEREAS, the City and the Contractor are required by the Alabama Competitive Bid Law and the Contract Documents to reduce their agreement to writing in the form of a written contract; and

WHEREAS, Alabama law at Title 11-43-56, *Code of Alabama*, 1975, provides that the City Council shall have the management and control of the finances and all of the property, real and personal, belonging to the City; and

WHEREAS, Title 11-43-43, *Code of Alabama*, 1975, provides that all legislative powers granted to cities shall be exercised by the City Council; and

WHEREAS, Title 11-40-1, *Code of Alabama, 1975*, declares municipalities bodies corporate and gives them the power to contract and be contracted with; provided, however, that the contract is in writing as required by Title 11-47-5, *Code of Alabama, 1975*; that the execution and delivery of the contract shall have first been approved by the City Council, *Town of Boligee v. Greene County Water and Sewer Authority, 77* So.3d 1166 (2011), in the form of an ordinance or resolution, *Van Antwerp, et al v. Board of Commissioners of City of Mobile*,217 Ala. 201, 115 So. 239 (1928); that the contract be signed by the Mayor as required by Title 11-43-83, *Code of Alabama, 1975*; and that the contract be signed by the City Manager as required by Title 11-43-21(7), *Code of Alabama, 1975*.

NOW, THEREFORE, in consideration of the premises, the mutual covenants hereinafter contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, City and Contractor hereby mutually covenant and agree as follows:

- **1.** The recitals set forth above are incorporated herein by reference as thought set out fully herein.
- 2. The Contractor is hereby granted the sole and exclusive franchise, license and privilege within the territorial jurisdiction of the City and shall furnish all personnel, labor, equipment, trucks and all other necessary items to provide Residential Garbage and Trash Collection and Disposal, and Residential Recycling Collection services as specified and to perform all of the work called for and described in the Contract Documents.
- **3.** The Contract Documents shall include the following documents, and the Contract does hereby expressly incorporate same herein as fully as if set forth verbatim in the Contract:

- **4.** All provisions of the Contract Documents shall be strictly complied with and conformed to by the Contractor, and no amendment to this Contract shall be made except upon the written consent of the parties, which consent shall not be unreasonably withheld. No amendment shall be construed to release either party from any obligation of the Contract Documents except as specifically provided for in such amendment.
 - **5.** This Contract is entered into subject to the following conditions:
- **a.** The Contractor shall procure and keep in full force and effect throughout the term of this Contract all of the insurance policies specified in, and required by, the Contract Documents.
- **b.** Neither the Contractor nor the City shall be liable for the failure to perform their duties if such failure is caused by a catastrophe, riot, war, governmental order or regulation, strike, fire, accident, act of God or other similar or different contingency beyond the reasonable control of the Contractor or the City.
- c. In the event that any provision or portion thereof of any Contract Document shall be found to be invalid or unenforceable, then such provision or portion thereof shall be reformed in accordance with the applicable laws. The invalidity or unenforceability of any provision or portion of any Contract Document shall not affect the validity or enforceability of any other provision or portion of the Contract Documents.
- 6. The notice advertised by the City of Vestavia Hills inviting sealed competitive bids for the collection and disposal services for single-family residential garbage, trash, recyclables, leaves and storm debris requested that bidders submit bids for several different levels of service.

The Contractor, AmWaste, LLC, submitted its sealed bid to the City of Vestavia Hills on May 28, 2020. A copy of that Bid is attached hereto, marked as Exhibit 2b and is incorporated into this Contract by reference as though set out fully herein.

On August 24, 2020, the City Council approved and adopted Ordinance Number 2946 accepting Level F as set forth on Contractor's Bid Exhibit 3b and authorized and directed the Mayor and City Manager to execute and deliver this Contract for and on behalf of the City.

For the sake of clarity and the benefit of the general public, the City and Contractor wish to set forth the services to be performed by the Contractor for and during the term of this Contract or

any extension thereof.

Anything contained in the Contract Documents to the contrary notwithstanding, the City and Contractor expressly and mutually agree that the services to be performed by the Contractor shall be as follows:

- **a.** <u>FIRST WEEKLY CONTAINERIZED PICKUP:</u> The first weekly containerized pickup shall be limited to "garbage" as defined in Section III-A-5 of the Specifications. The Contractor shall deliver the garbage to an Alabama Department of Environmental Management (ADEM) approved facility for disposal.
- **b.** <u>SECOND WEEKLY CONTAINERIZED PICKUP:</u> The occupant of the single-family residential dwelling may put "garbage" (as defined in Section III-A-5 of the Specifications) and "recyclable materials" (as defined in Section III-A-8 of the Specifications) in the cart/container for the second weekly containerized pickup.

Contractor shall deliver all second weekly containerized pickups to Repower South in Montgomery, Alabama. The combined waste for all said second weekly containerized pickups (garbage and recyclable materials) shall be separated by Repower South. The recycled materials shall be processed thereafter in the normal recycling course of business.

- **c.** <u>LANDFILL</u>: Contractor hereby guarantees that for and during the term of this Contract or any extension thereof, the Contractor shall always deliver all of the **second** weekly containerized pickup to a facility that will either:
- i. Separate the garbage from the recyclable materials and be processed as described in section b. above; or
- **ii.** Reduce or repurpose the combined material as comingled with a process that significantly reduces the amount of waste material that will require landfilling.
- **iii.** If Contractor and Repower South cease to do business for any reason whatsoever, then in such event the City and Contractor expressly agree that they will mutually agree on another landfill to perform the services formerly done by Repower South and amend this Contract in writing to reflect that change.
- **d.** Trash, as defined in Section III-A-6 of the Specifications, shall be picked up by the Contractor and disposed of at the landfill in Sylvan Springs, Alabama within ten (10) days after the occupant has placed said trash at curbside.

e. <u>MONTHLY COST:</u> In consideration of the services performed by Contractor, as set forth in sections a, b, c and d above, the City shall pay to Contractor each month as shown on Exhibit 2b being an amount equal to the number of single-family residential dwellings serviced by Contractor that month multiplied by \$22.27 per said dwellings.

7. MISCELLANEOUS

- **a.** <u>NON WAIVER:</u> The failure of the City to insist, in any one or more instances, upon a strict performance of any of the covenants of this Contract, or to exercise any option herein contained, shall not be construed as a waiver, or a relinquishment for the future of such covenant or option, but the same shall continue and remain in full force and effect.
- **b.** <u>WAIVER OF MODIFICATION:</u> Any waiver, alteration or modification of any of the provisions of this Contract or cancellation or replacement of this Contract shall not be valid unless in writing and signed by the City and Contractor. This Contract may be amended at any time by written agreement of the parties signatory hereto. No claims for any extra work or materials shall be allowed unless covered by written agreement of the parties.
- **c.** <u>NOTICES:</u> Any and all notices required or permitted to be given under this Contract will be sufficient if furnished in writing and sent by Registered Mail to the parties' last known address.
- **d.** <u>CONSTRUCTION OF TERMS:</u> The City and Contractor negotiated the terms, provisions and conditions of this Contract and both parties had the equal opportunity for input for the drafting of this Contract. Therefore, any ambiguities of this Contract shall be construed fairly and equitably regardless of the participation of either party in drafting this Contract. The reference in terms to gender and number shall be modified as may be appropriate.
- **e.** <u>GOVERNING LAW:</u> This Contract shall be interpreted, construed and governed to the laws of the State of Alabama. The jurisdiction and venue for the resolution of any dispute shall be in Jefferson County, Alabama.
- **f.** <u>ARTICLE AND SECTION HEADINGS:</u> The article and section headings and captions contained herein are included for convenience only, and shall not be considered a part hereof or affect in any manner the construction or interpretation hereof.
- **g.** <u>EXECUTION IN COUNTERPARTS:</u> The Contract may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.
- **h.** <u>BINDING EFFECT:</u> The Contract shall inure to the benefit of, and shall be binding upon City and Contractor, and their heirs, successors and assigns.

ORDINANCE NUMBER 2945

AN ORDINANCE APPROVING AND ADOPTING THE GENERAL FUND BUDGET, A SPECIAL REVENUE FUND BUDGET, A CAPITAL PROJECT FUND BUDGET, AND AN INFRASTUCTURE AND COMMUNITY SPACES PROJECT FUND BUDGET FOR THE CITY OF VESTAVIA HILLS FOR THE PERIOD BEGINNING OCTOBER 1, 2020 UNTIL SEPTEMBER 30, 2021.

WHEREAS, the City Manager has prepared and presented a "general fund budget" which has been reviewed and amended by the City Council for said period reflecting anticipated expenditures in the amount of \$47,783,673 including transfers out, to be effective for the period beginning October 1, 2020, through September 30, 2021; and

WHEREAS, the City Manager has prepared a "special fund budget" for said period reflecting anticipated expenditures in the amount of \$3,565,670 including transfers from the General Fund, to be effective for the period beginning October 1, 2020, through September 30, 2021; and

WHEREAS, the City Manager has prepared a "capital projects fund budget" for said period reflecting expenditures in the amount of \$4,485,967 to be effective for the period beginning October 1, 2020, through September 30, 2021.

WHEREAS, the City Manager has prepared an "infrastructure and community spaces fund budget" for said period reflecting expenditures in the amount of \$4,434,491 to be effective for the period beginning October 1, 2020, through September 30, 2021.

WHEREAS, Title 11-43-57, Code of Alabama, 1975, provides as follows:

Annual appropriation of funds for expenditures of all departments and interest on indebtedness: In all cities, the Council shall appropriate the sums necessary for the expenditures of the several City departments and for the interest on its bonded and other indebtedness, not exceeding in the aggregate within ten (10) percent of its estimated expenses, and such City Council shall not appropriate in the aggregate an amount in excess of its annual legally authorized revenue. But, nothing in this section shall prevent such cities from anticipating their revenues for the year for which such appropriation was made, or from contracting for temporary loans as provided in the applicable provision of this title, or from bonding or refunding their outstanding indebtedness or from appropriating anticipated revenue at any time for the current expenses of the City and interest on the bonded and other indebtedness of the City; and

WHEREAS, the City Council agrees to approve and adopt ninety (90) percent, or \$43,005,306, of the municipal "general fund budget" for the City of Vestavia Hills for fiscal year 2020-2021 upon the terms, conditions, and provisions set forth below; and

WHEREAS, the City Council agrees to approve and adopt ninety (90) percent, or \$3,209,103, of the municipal "special revenue fund budget" for the City of Vestavia Hills for fiscal year 2020-2021 upon the terms, conditions and provisions set forth below; and

WHEREAS, the City Council agrees to approve and adopt ninety (90) percent, or \$4,037,370, of the "capital project fund budget" for the City of Vestavia Hills for fiscal year 2020-2021 upon the terms, conditions and provisions set forth below.

WHEREAS, the City Council agrees to approve and adopt ninety (90) percent, or \$3,991,042, of the "infrastructure and community spaces project fund budget" for the City of Vestavia Hills for fiscal year 2020-2021 upon the terms, conditions and provisions set forth below.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vestavia Hills, Alabama, as follows:

1. The municipal "general fund budget" for the City of Vestavia Hills, Alabama, prepared by the City Manager and submitted to the City Council is hereby approved and adopted to the extent of expenditures of \$43,005,306, which said amount is not exceeding the aggregate within ten (10) percent of the estimated expenses:

\$47,783,673 multiplied by 90% equals \$43,005,306; and

2. The municipal "special revenue fund budget" for the City of Vestavia Hills, Alabama, prepared by the City Manager and submitted to the City Council is hereby approved and adopted to the extent of expenditures of \$3,209,103 which said amount is not exceeding the aggregate within ten (10) percent of the estimated expenses:

\$3,565,670 multiplied by 90% equals \$3,209,103; and

3. The "capital projects fund budget" for the City of Vestavia Hills, Alabama, prepared by the City Manager and submitted to the City Council is hereby approved and adopted to the extent of expenditures of \$4,037,370 which said amount is not exceeding the aggregate within ten (10) percent of the estimated expenses:

\$4,485,967 multiplied by 90% equals \$4,037,370; and

4. The "infrastructure and community spaces fund budget" for the City of Vestavia Hills, Alabama, prepared by the City Manager and submitted to the City Council is hereby approved and adopted to the extent of expenditures of \$3,991,042 which said amount is not exceeding the aggregate within ten (10) percent of the estimated expenses:

\$4,434,491 multiplied by 90% equals \$3,991,042; and

5. The City Manager is hereby authorized to expend the sum of \$43,005,306 from the General Fund, \$3,209,103 from the Special Revenue Fund, \$4,037,370 from the Capital Projects Fund, and \$3,991,042 from the Infrastructure and Community Spaces Fund for municipal expenses for the period beginning October 1, 2020, and ending September 30, 2021.

6. Copies of the budget outlines are attached hereto, marked as Exhibit "A" and incorporated into this Resolution by reference as though set out fully herein.

BE IT FURTHER ORDAINED, this Ordinance shall become effective immediately upon its approval and adoption.

- 2. All financing contracts and all related documents for the closing of the financing (the "Financing Documents") shall be consistent with the foregoing terms. All officers and employees of the Governmental Entity are hereby authorized and directed to execute and deliver any Financing Documents, and to take all such further action as they may consider necessary or desirable to carry out the financing of the Project as contemplated by the proposal and this resolution. The Financing Documents shall include a Financing Agreement and a Project Fund Agreement as Regions may request.
- 3. The Finance Officer is hereby authorized and directed to hold executed copies of the Financing Documents until the conditions for the delivery of the Financing Documents have been completed to such officer's satisfaction. The Finance Officer is authorized to approve changes to any Financing Documents previously signed by Governmental Entity officers or employees, provided that such changes shall not substantially alter the intent of such documents or certificates from the intent expressed in the forms executed by such officers. The Financing Documents shall be in such final forms as the Finance Officer shall approve, with the Finance Officer's release of any Financing Document for delivery constituting conclusive evidence of such officer's final approval of the document's final form.

- 4. The Governmental Entity shall not take or omit to take any action the taking or omission of which shall cause its interest payments on this financing to be includable in the gross income for federal income tax purposes of the registered owners of the interest payment obligations under the Financing Documents. The Governmental Entity hereby designates its obligations to make principal and interest payments under the Financing Documents as "qualified tax-exempt obligations" for the purpose of Internal Revenue Code Section 265(b)(3).
- 5. The Governmental Entity intends that the adoption of this resolution will be a declaration of the Governmental Entity's official intent to reimburse expenditures for the Project that is to be financed from the proceeds of the Regions financing described above. The Governmental Entity intends that funds that have been advanced, or that may be advanced, from the Governmental Entity's general fund, or any other Governmental Entity fund related to the Project, for Project costs may be reimbursed from the financing proceeds.
- 6. The officers of the Governmental Entity and any person or persons designated and authorized by any officer of the Governmental Entity to act in the name and on behalf of the Governmental Entity, or any one or more of them, are authorized to do and perform or cause to be done and performed in the name and on behalf of the Governmental Entity such other acts, to pay or cause to be paid on behalf of the Governmental Entity such related costs and expenses, and to execute and deliver or cause to be executed and delivered in the name and on behalf of the Governmental Entity such other notices, requests, demands, directions, consents, approvals, orders, applications, certificates, agreements, further assurances, or other instruments or communications, under the corporate seal of the Governmental Entity, or otherwise, as they or any of them may deem necessary, advisable, or appropriate in order to (a) complete the plan of financing contemplated by the Financing Documents, (b) carry into effect the intent of the provisions of this resolution and the Financing Documents, and (c) demonstrate the validity of the Financing Documents, the absence of any pending or threatened litigation with respect to the Financing Documents and the plan of financing contemplated by the Financing Documents, and the exemption of interest on the interest payment obligations under the Financing Documents from federal and State of Alabama income taxation.

7. All prior actions of Governmental Entity officers in furtherance of the purposes of this resolution are hereby ratified, approved and confirmed. All other resolutions (or parts thereof) in conflict with this resolution are hereby repealed, to the extent of the conflict. This resolution shall take effect immediately.

WHEREAS, the Mayor and the City Council agree it is in the best interest of the public to grant said employees who have been significantly exposed to the general public and the COVID-19 virus in performance of their daily job duties such pay for a period of 3 months.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF VESTAVIA HILLS, ALABAMA, AS FOLLOWS:

- 1. The City Manager is hereby authorized to designate those essential employees of the City that have been significantly exposed to the general public and the COVID-19 virus in the daily performance of their job duties and grant these select employees a premium pay of 5% for a period of 3 months; and
- 2. Said increase shall become effective September 1, 2020 and continue until December 31, 2020; and
- 3. This Resolution Number 5234 shall become effective beginning immediately upon adoption and approval.

AN ORDINANCE GRANTING CONDITIONAL USE APPROVAL TO ALLOW PERIMETER SECURITY FENCING; MAJOR MECHANICAL REPAIR OF MOTOR VEHICLES AND SHORT-TERM STORAGE OF MOTOR VEHICLES

WHEREAS, on December 13, 2010, the City Council of the City of Vestavia Hills, Alabama, adopted and approved Ordinance Number 2331, also known as the City of Vestavia Hills Zoning Code; and

WHEREAS, CRM Enterprises, LLC, ("the Owner") is the owner of the property located at 1452 Montgomery Highway, property that is zoned Vestavia Hills B-3 (conditional business district); and

WHEREAS, the property located at 1452 Montgomery Highway is more particularly described as Lot 2-B, according to a Resurvey of Lots 1-A, Meeks 1st Addition to Shady Springs an part of Lot D-1, being a part of a Resurvey of Lot D, Meeks 1st Addition to Shady Springs as recorded in Map Book 123, Page 59, Jefferson County, Alabama; and

WHEREAS, the Owner, wishes to encompass the property's perimeter with a chain link security fence and utilize the property for the purpose of major mechanical repair of motor vehicles and short-term storage of motor vehicles.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VESTAVIA HILLS, ALABAMA, AS FOLLOWS:

- 1. Conditional Use approval is hereby granted to allow the Owner to enclose the property with perimeter security fencing and utilize the property for the purpose of major mechanical repair of motor vehicles and short-term storage of motor vehicles on the property located at 1452 Montgomery Highway with the following conditions:
 - a. A minimum 5' landscape buffer shall be installed in front of said fencing either on ALDOT Right-of-way or on subject property, said landscaping plan shall be subject to the approval of ALDOT (if on ALDOT ROW) and the Vestavia Hills Design Review Board prior to installation in order to negate the visual effect of the proposed fencing; and

- b. A geo-technical report, prepared by a certified engineer to be reviewed and approved by the City Engineer and the Building Safety Official;
- c. Pursuant to a geo-technical report dated July 9, 2020 completed by BECC and submitted to the City by the Owner following the Planning and Zoning Commission meeting, Richard A. Rhinehart, P.E., Principal Geotechnical Engineer stated "The slope is currently stable, however, future surface water drainage over the face of the slope could cause future erosion and instability" which prompted a requirement from Building Safety Official to obtain an annual review of the stability of the slope as determined by a geotechnical engineer to be submitted to the Building Official on an annual basis for the purposes of safety the first annual report due prior to December 31, 2021 and annually thereafter; and
- d. Approval is based upon the site plan presented with the elimination of one access to Montgomery Highway; and
- 2. Said conditional use shall limited to the property located at 1452 Montgomery Highway and shall continue in perpetuity pursuant to the Zoning Code until such time as use ceases to exist on said property for a period of one year; and
- 3. This Ordinance Number 2942 shall become effective immediately upon adoption, approval and publishing/posting pursuant to Alabama law; and

• GENERAL DISCUSSION: This request is for 1452 Montgomery Highway, the former AAMCO Transmission repair. As you recall, there was a tremendous rock slide that occurred there early last year. (see attached photo of embankment now). It did a good bit of damage and crushed some automobiles. The AAMCO has moved and CRM Enterprises (Sonoco) purchased the property. Sonoco is adjacent to this property, just to the south. The owner, Mr. Birdsong, represented by his legal counsel, Loring Jones III, is requesting a conditional use approval for major car repair, short-term storage of vehicles on the property and installation of a 6' black chain link fence with shading and barb wire (see attached pictures) around the front and side of the property to the front property line.

Major car repair was there previously with the AAMCO, however, the rock slide occurred more than 12 months ago so the use is no longer permissible under the City's newer zoning code. This request is to allow it once again on the property.

The other, temporary vehicle storage, is to allow towed vehicles as well as vehicles waiting for service to be stored on the property. The request requires security so the owner wishes to install a 6' chain link fence with shading along the front and side boundaries of the property. This will bring the fencing to the front curbing of Highway 31.

Presently, the request shows the 2 accesses to Highway 31 with security gates. However, the property owner installed an access between the properties and the City Engineer has required a plan review. It is unknown at this time if the Highway 31 accesses will be closed in lieu of the new southern inter-property access.

Staff has reviewed this request and indicated that the conditional uses were needed in order that the owner may use the property as he desires. The staff also recommended that if the property owner proceed with the request, that landscaping be installed to mitigate the effects of the fencing from Montgomery Highway. The request came

with proposed landscaping, but the landscaping is drawn to be installed on ALDOT ROW which the City Engineer states will require ALDOT approvals and permitting. If the conditional use is approved, the Staff asks Council to consider require the landscaping with or without ALDOT's approval (without will require the removal of some of the asphalt/concrete and installing soil suitable for landscaping).

• <u>VESTAVIA HILLS COMPREHENSIVE PLAN</u>: The plan labels this site as Commercial Core/Village Center

• STAFF REVIEW AND RECOMMENDATION:

1. City Planner Review: I have looked at all of the relevant zoning / subdivision requirements related to this proposal, including application, notification, setbacks, area of lot development, etc. Notification has been sent to property owners pursuant to Alabama law. I have reviewed this request and find it does meet the minimum requirements of the proposed zoning.
