Altadena Valley and Wald Park phase 3 are both progressing. Most of the work currently being completed at Wald Park is underground.

Jamie Lee's Report:

- Altadena Valley –EDG is completing the documents and should begin moving dirt this week
- Summer Basketball Program We have 112 boys and 14 teams. Will run games June 6 July 18 on Tuesdays and Thursdays at the VHCC. Playing 4v4, our staff and or the VHHS boys' basketball will be officiating.
- Mike Shaw Legislative Money Spoke with him last week. Should have the money soon. Designated for upgraded flooring in the fitness rooms and track at East.
- Senior Update Sandi gave an update on the services being offered for Seniors; postcards, trips, special events, etc.
- Disc Golf All the disc golf at SHAC have been moved to VH land.
- Wald The green space is currently being monitored. Raynor is working with the contractor and with Sheety. They are going to put down fertilizer and set the irrigation on a different schedule. They are trying to do whatever they can to save the grass and not have to replace.

General Discussion:

- Lightning Detection all the systems were tested recently. There are some of the citizens who hear and adhere to the alerts and some who do not. Paul suggested that we communicate with the Boards what to do, train them on the alert system and then also make sure they know the consequences of not "playing buy the rules". We (Parks and Recreation staff) will look into differentiating between the sounds, etc. in order to make it easier to know what is being communicated.
