Meeting was called to order at 7:00 AM by Lyles Box.

Kirk McCulley led us in Prayer and the Pledge.

Meeting Minutes from May 17th, 2022 Park Board Meeting. Motion to approve by Kirk McCulley and 2nd by Mitch Bevill. Motion approved.

Mayor's Report:

Melinda reported that the Mayor was planning a "Scams Against the Elderly" program to be held at the VHUMC on August 23, 2022.

Jamie Lee's Report:

- Thank you to the Board for all their help and responsiveness over the past 3 months.
- We are seeing progress at the New CC. Have been told we can move furniture in around the 22nd. There is still a lot of cleaning to be done. They are having drainage issues that have held off the paying – hopefully next week. The Mayor has an event that is currently planned for there on September 20, 2022.

- Altadena Valley clean-up is ongoing by Parks and Rec staff. Sheety will be cutting in 2 weeks and then our crews will go in and weed eat and cleanup. Shelby County has agreed to provide funding for the bathrooms in Phase 1.
- Trail at SHAC drainage and overgrowth have been an issue. Our crews are in the process of cutting and cleaning up. Disc Golf course should be cut this week.
- Lifeguards Numbers are diminishing moving toward Labor Day. This past Sunday there were only 3 guards available to work.
- Flag Football Draft was this past Saturday around 400 players are signed up to play.
- Last year, not including swim or soccer, our programs consisted of 400 teams, 3500 games and 4500 players.
- The current Recreation Center will not be turned over to the school board until we are completely moved out from the facility. Jamie is staying in communication with Laura, Myra and Dr. Martin.

Old Business:

Fee Structure (handout included)

- There is a track pass option that was approved in November of 2021. We feel that is going to be difficult to police. It was decided that for now staff are going to monitor the cameras and expect participants to be honest.
- The pay by monthly fee was discussed. Staying the same for now.

Parks and Leisure Field Use Policy

- Kirk is still working on rewriting the policy. It needs to be simplified. Problem is the "Loop Holes" that have been discovered.
- Lyles suggested that they present at the next work session. Kirk suggested that a couple of the group that are familiar discuss prior to the work session.
- Jamie we are working to say "yes" to everyone but we need some clarification.

New Business:

Coach Safely Requirements / Background Checks

- It is the law, every 2 years.
- If they have not completed by the first of the season, what is the Board's expectation? No field space and No games.

Pickleball League (handout included)

• Kirk stated that if it is a "real" league with structure then a non-resident can sign up and join the league just like the youth sports. Rocky reported on Hoover's policy at the met for open play. Jamie stated that we need the PB to decide on a fee structure for open play. Discussion about policies and structure. Jamie stated that gym space interfering with other sports is not going to be an issue. We have gym space. We just need direction, policies and fees from the Park Board on how they wish for us to handle. Concensus of the Board is that the league needs to be structured and a true league to allow for non-residents to participate and there will be no non-residents in the beginning for at least the first 3-6 months and then they will reevaluate.

Downes Syndrome Awareness (request included)

• Sunday, October 23, 2022 – Wald park. Kirk asked Chad Long if they can move baseball for that day, Chad agreed. Park Board decided that this event is important

to the community and they have waved the fees and agreed to all the outlined request. Kirk made the motion, Paul second, motion passed.

League Reports:

- Rocky Harmon Soccer Fall Registration is concluded. They have 720 recreational players. Liberty Cup Tournament will be played over the next 2 weekends; girls this weekend and boys next. There is an ACT prep class at the SHAC meeting room every Monday night. They also have Kenny Davis at the fields on Monday nights through Thanksgiving. He is a trainer and will be happy to assist any sport that needs him.
- Oliver Aaron VHHS Swim they have 2 meets at the VHAC, September 6th and September 27th. He has worked with Jamie and William to secure practice times and dates.

Citizens Comments: Kirk made a motion and Mitch second to wave the fee for the MLP pitch, hit and run that will be held at Wald Park. Motion passed.
