Meeting was called to discuss changes in the City's Insurance carrier.

Paul Head gave an overview of the New Insurance and why it is necessary to make the change. Jamie Lee explained what has been done by his department to get all of the "pre-requisites" together in order to assure coverage. We have sent policies to the insurance company and they have approved documents. The Park Board needs to review these policies and approve them as well.

Mayor Curry asked that Captain Ware join the Park Board to review and give input if needed. He stated that the only thing he would suggest would be to add a bullet point to the child molestation piece of the documents to state that information would immediately be turned over and reported to the police if there were any suspected abuse.

In order to ensure "outside" sports boards adhere, the documents can and will be added to Sportsman and they will electronically sign. We will put together a document that each coach will have to have "signed off" by a staff member that they have checked all their boxes.

Jamie asked if we could put together a contract agreement with the classes, sports, etc. and the Park Board approved.

Jamie will check with the insurance company and ask what we will need from the OTM teams.

Paul Head made a motion, Kirk McCulley 2nd to approve the policies presented with the addition of the statement; Regarding abuse of any kind being reported immediately to law enforcement. Motion carried.

Kirk McCulley made a motion to adjourn, Lyles Box 2nd; Meeting adjourned at 8:00am.

Meeting was called to order at 7:31 AM by Lyles Box.

Jamie Lee's Report:

- Wald Park Phase 3 Asphalt has been poured. Tennis courts are ready to go and pickle ball courts are about 2 weeks out.
- Altadena Valley Phase 1 Project is nearing completion. Parking lot has been poured and landscaping going in.
- Light Repairs --We have several lights out across the city. East football lights have been fixed. Turf field lights are out. Issue with getting a lift to access the lights on the turf fields.
- TULIP change update We have worked to make some simple changes to the policy to make sure the City is covered in all cases.
- Grand Slam 10/1 Tournament Baseball Director refusing to move fields to
 accommodate rec baseball after being notified in advance about rec games. Jamie Lee
 made the decision to no longer allow Grand Slam baseball tournaments during rec
 season. They will be allowed to use during June & July months only.
- Basketball Update –Girls basketball 278 participants. Practices will begin October 30th.
 Boys basketball 765 participants. Practices will begin November 6th.

Discussion Items:

Partnership agreement – Jamie Lee requesting the Park Board to come up with a partnership agreement between the individual sport boards that are not currently being

administrated by P&R.

VHCC – Rental rate change request for the event spaces in the building. Jamie Lee is

policies need to stay the same across the board. Kirk McCulley suggested keeping

the policies the same for now and the Park Board would consider a change in the

future. Kirk McCulley would allow after the rec basketball season is completed. The

rec season is recognized from November 1st-Feburary 1st.
