**When is the vote?**  
*May 9, 2023.*

**If the vote passes, when will the new tax go into effect?**  
*October 1, 2023, and continuing each year thereafter.*

**Who is eligible to vote?**  
*Any registered voter in the city of Vestavia Hills.*

**When was the last time Vestavia Hills residents voted on a new tax specifically for schools?**  
*33 years ago in May 1990.*

**If passed, when would the new academic programs begin?**  
*Elementary STEM and World Languages classes would begin in the fall of 2023.*

**How long would it take for the facility improvements to be finished?**  
*Projects will begin in the 2023-24 school year and take approximately four years to complete.*

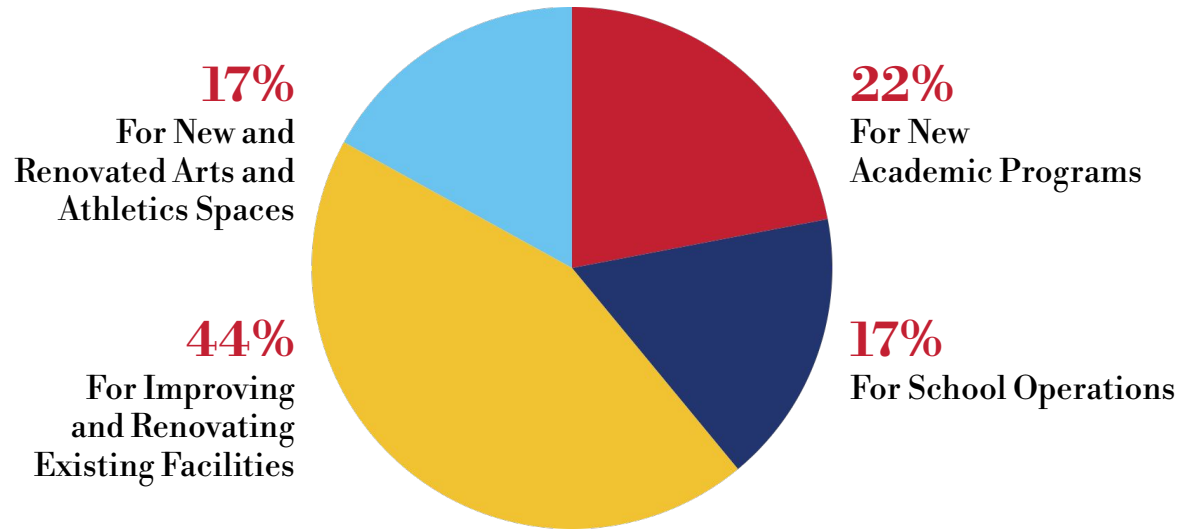
We will expand academic opportunities for students in math, science, and reading by adding STEM and world languages classes for elementary students and expanding STEM opportunities for secondary students.
